Journal articles require more detailed entries, including the journal title, volume, issue, and page numbers. The format is generally: Author's Last Name, First Name. Year. "Title of Article." Title of Journal Volume (Issue): Page Numbers. For example:

- Garcia, Maria. 2021. "Renewable Energy Policy Shifts." *Journal of Environmental Studies* 45 (3): 112-130.

- Kim, Sung-Ho, et al. 2019. "Advancements in Nanotechnology." *Science Today* 78 (1): 45-62.

## Web Page Entries

Citing web pages involves providing the author (if available), the publication date, the title of the page, and the URL. For pages without a specific publication date, use "n.d." (no date). The format: Author's Last Name, First Name (or Organization). Year. "Title of Web Page." Title of Website (if different from author). Accessed Date. URL. For example:

- National Institute of Health. 2023. "Understanding Climate Change Impacts." Accessed October 26, 2023. <https://www.nih.gov/climate-change>.
- Doe, John. n.d. "Tips for Effective Summarizing." Writing Resources Blog. Accessed October 26, 2023. <https://www.writingresources.com/summarizing-tips>.

## Common Scenarios in Summarizing with Chicago Author-Date
