Understanding the Author-Date System

Websites with a Corporate or Group Author

When a website's content is published by an organization or group rather than an individual, that entity serves as the author. This is common for official reports, news articles from organizational outlets, or informational pages from institutions.

Example in-text citation: (World Health Organization 2023)

Example reference list entry: World Health Organization. Global Health Report 2023. WHO Press, 2023. www.who.int/reports/global-health-2023.

Websites with No Author or Date

In instances where no author can be identified and no publication date is provided, you will use "n.d." for the date and omit the author. The title of the page or article then becomes the primary identifier in both the in-text citation and the reference list, often appearing in italics within the reference entry.

Example in-text citation: (Understanding SEO Basics)

Example reference list entry: Understanding SEO Basics. n.d. SEO Experts Blog. Accessed 10 March 2024. www.seoexpertsblog.com/understanding-seo.

In-Text Citations for Website Paragraphs

The proper placement and format of in-text citations for website paragraphs are crucial for clarity and adherence to Chicago style author-date guidelines. These citations serve as immediate signposts, directing your reader to the source of the information.

Direct Quotes

When quoting directly from a website, it's essential to include the author and year in your parenthetical citation. If the website has pagination, you would also include the page number.

However, most web pages do not have formal page numbers. In such cases, you might refer to a section heading or paragraph number if it aids in locating the specific text.

Example without author in sentence: "Digital marketing strategies are constantly evolving" (Miller 2021).

Paraphrases and Summaries

Even when you are paraphrasing or summarizing information from a website, you must provide an in-text citation. This acknowledges that the ideas, not just the exact words, originate from a specific source. The format remains the same: author's last name and the year of publication.

Example: Online content creators must remain adaptable to the dynamic nature of digital marketing techniques (Miller 2021).

Creating the Reference List for Websites

The reference list is the cornerstone of any citation system, providing the complete details for each source you've referenced. For websites, this list needs to be meticulously constructed to ensure readers can easily access the original content.

Essential Elements of a Website Reference Entry

A well-formed Chicago style author-date reference for a website typically includes the following:

Author's Last Name, First Name. (If no individual author, use the organization or group name.)

Title of the Specific Page or Article. (In quotation marks.)

Formatting Guidelines for the Reference List

The reference list should be alphabetized by the author's last name. If there is no author, alphabetize by the first significant word of the title. Entries should be single-spaced within the entry and double-spaced between entries. Hanging indents are also used, meaning the first line of each entry is flush left, and subsequent lines are indented.

- Organization Name. (Year, Month Day). Title of specific page. Title of Website. Retrieved from URL
- Title of Specific Page. (n.d.). Title of Website. Retrieved from URL

Best Practices for Chicago Style Author-Date on Websites

Websites are inherently dynamic. If a page you cited is updated or removed, your reference should reflect the information as you accessed it. Including the access date is crucial in these situations. If a page is significantly updated, you may need to cite the new publication date if it's available.

Missing Author Information
