Understanding Chicago Style Author-Date

Entries in the reference list are typically arranged alphabetically by the author's last name. If multiple works by the same author are cited, they are listed chronologically by publication year. For works with no author, the entry is alphabetized by the first significant word of the title (excluding articles like "A," "An," and "The"). This systematic organization is crucial for readers to efficiently locate the specific source they are interested in, making your research accessible and transparent.

Common Source Types and Examples

Books

Citing books in Chicago author-date style requires attention to author names, publication year, title, and publisher information. For a single-author book, the in-text citation would be (AuthorLastName Year). The reference list entry would follow the format:

AuthorLastName, FirstName. Year. Title of Book. City: Publisher.

For example, if citing a book by Jane Doe published in 2022 titled "The Art of Citation," the in-text citation would be (Doe 2022). The reference list entry would appear as: Doe, Jane. 2022. The Art of Citation. Chicago: University of Chicago Press.

Journal Articles

Citing journal articles involves including the author, year, article title, journal name, volume, issue number, and page range. The in-text citation format remains (AuthorLastName Year). The reference list entry for a journal article is: AuthorLastName, FirstName. Year. "Title of Article." Title of Journal Volume (Issue): Page range.

Consider an article by John Smith titled "Digital Humanities Trends" in the Journal of Academic Research, published in 2021, volume 15, issue 2, on pages 112-130. The in-text citation would be (Smith 2021). The reference list entry would be: Smith, John. 2021. "Digital Humanities Trends." Journal of Academic Research 15 (2): 112-130.

Websites

Citing web sources requires careful attention to the author (if available), publication date or last updated date, title of the page or document, and the retrieval date and URL. The in-text citation typically uses the author's name and year (if available), or a shortened title and year. The reference list entry would be: AuthorLastName, FirstName (if known). Year (if known). "Title of Web Page." Title of Website. Last modified Month Day, Year (if available). Accessed Month Day, Year. URL.

If an article titled "Online Research Methods" on the "Academic Hub" website was last updated on March 15, 2023, and you accessed it on October 26, 2023, with the URL example.com/research, the reference list entry might be: Academic Hub. 2023. "Online Research Methods." Last modified March 15, 2023. Accessed October 26, 2023. <https://example.com/research>.

Other Media

The principles for citing other media, such as films, interviews, or podcasts, follow the same logic of providing sufficient information for retrieval. For a film, you would include the director, year, film title, and studio. For a podcast episode, you would list the host, year, episode title, podcast name, and episode number or URL.

For example, a documentary film directed by Maria Garcia in 2020 titled "The Future of Learning," produced by Horizon Films, would be cited in text as (Garcia 2020). The reference list entry would be: Garcia, Maria, dir. 2020. The Future of Learning. Produced by Horizon Films.

Citing Multiple Authors

When a source has two or three authors, all author last names are included in the in-text citation, separated by "and." For example, (Davis and Miller 2018). In the reference list, all author names are listed. If a source has four or more authors, only the first author's last name is given in the in-text citation, followed by "et al." (and others), along with the year: (Johnson et al. 2022). In the reference list, however, all authors are listed.

For sources with a corporate author or organization as the author, the organization's name is used in place of an individual author's name in both the in-text citation and the reference list. For example, (World Health Organization 2021) for an in-text citation, and World Health Organization. 2021. *Global Health Report*. Geneva: WHO Press. in the reference list.

Citing Sources with No Author or Date

When a source lacks an author, the title of the work is used in the in-text citation, often shortened if it's lengthy, followed by the year or a more specific date if available. The title is italicized or placed in quotation marks, depending on the source type, similar to how it would appear in the reference list. For example, if a report titled "Annual Economic Review" has no author and was published in 2023, the in-text citation might be (Annual Economic Review 2023).

For sources without a publication date, the abbreviation "n.d." (no date) is used in place of the year in both the in-text citation and the reference list entry. For example, (Thompson n.d.) and Thompson, Sarah. n.d. *Understanding Research Ethics*. This indicates that no specific date of publication could be found for the source. It is important to note that for online sources, a "last updated" or "accessed" date can often be found, which should be used instead of "n.d." if available.
