Understanding the Two Chicago Style Systems

The Chicago Manual of Style (CMOS) offers two primary citation systems, and it is imperative to understand which one your instructor or publisher requires for your psychology paper. Key Components of a Chicago Style Bibliography

A Chicago style bibliography, whether a reference list or a bibliography section, serves as an alphabetical compilation of all the sources you have cited within your paper. It is more than just a list; it is a testament to your research's foundation and allows your readers to locate and verify the information you have presented. Each entry in the bibliography must contain specific details that uniquely identify the source.

The essential elements typically included in a Chicago style bibliography entry are author(s), title of the work, publication information (publisher, year, journal title, volume, issue, pages), and for online sources, a DOI or URL and access date. For works with three or more authors, cite only the first author's last name followed by "et al." and the year (e.g., Ainsworth et al., 1978). This convention applies to both the Author-Date system and the notes in the Notes-Bibliography system.

Citing Subsequent Works by the Same Author

If you cite multiple works by the same author in the same year, you must distinguish them by appending lowercase letters to the year, both in the in-text citation and in the bibliography entry. For instance, if an author published two works in 2020, they might be cited as (Frued, 2020a) and (Frued, 2020b), and their respective bibliography entries would also be marked with 'a' and 'b'.

Crafting the Bibliography: General Principles

The bibliography, or reference list, is typically alphabetized by the author's last name. If a work has no author, it is alphabetized by the first significant word of the title, excluding articles like "A," "An," or "The." Each entry begins with the author's name (last name first), followed by the title of the work, and then publication details. For the Author-Date system, the year of publication immediately follows the author's name.

A crucial formatting element in Chicago style bibliographies is the use of a hanging indent. This means the first line of each entry is flush with the left margin, and all subsequent lines of that entry are indented. Citing Journal Articles in Psychology

Notes-Bibliography System for Journal Articles

In the Notes-Bibliography system, the bibliography entry for a journal article is similar but omits the year from its immediate position after the author. Instead, the year appears with the volume and issue information. The primary citation happens in the footnotes or endnotes. A bibliography entry would be formatted as:

- Baumeister, Roy F. "Identity, Self-Presentation, and Self-Esteem: A Social Cognitive Perspective." *Psychological Inquiry* 8, no. 1 (1997): 37-41.

The footnote or endnote for this article would include more publication details and potentially different punctuation, often with the author's name presented first name first.

Citing Books and Book Chapters in Psychology

Books and book chapters are also frequently cited in psychology research. The citation format for these sources will also vary slightly between the two Chicago style systems.

Author-Date System for Books

For the Author-Date system, a book citation includes the author's last name, first initial(s), the year of publication in parentheses, the book title (italicized), and the publisher's city and name. For edited books, the editor(s) would be listed first. A typical entry would be:

- Kahn, Robert L., and Daniel Katz. 1966. *The Social Psychology of Organizations*. New York: John Wiley & Sons.

Author-Date System for Book Chapters

When citing a chapter within an edited book, you need to include the chapter author(s), the chapter title, the editor(s) of the book, the book title (italicized), and the page range of the chapter, followed by the publication information. For example:

- Fiske, Susan T. 2004. "Stereotyping, Prejudice, and Discrimination." In *The Handbook of Social Psychology*, edited by Susan T. Fiske, Daniel T. Gilbert, and Gardner Lindzey, 357-404. 4th ed. New York: McGraw-Hill.

Notes-Bibliography System for Books and Chapters

In the Notes-Bibliography system, the bibliography entry for a book omits the year from its immediate position after the author. The year appears at the end of the citation, before the publisher information. For chapters, the structure is similar, with the year appearing last before publication details. The footnotes or endnotes would contain the full publication details and would cite the source differently from the bibliography entry.

Citing Dissertations and Theses in Psychology

Dissertations and theses represent original research and are often valuable resources in academic fields like psychology. Their citation format in Chicago style requires specific information to distinguish them from published books.

Author-Date System for Dissertations/Theses

For the Author-Date system, a dissertation or thesis citation includes the author's last name, first initial(s), the year of completion in parentheses, the dissertation or thesis title (*italicized*), and the type of work (e.g., Ph.D. dissertation, Master's thesis) followed by the university from which it was awarded. Notes-Bibliography System for Dissertations/Theses

In the Notes-Bibliography system, the bibliography entry will follow a similar structure, with the year appearing closer to the end of the entry, and the footnotes or endnotes providing more complete publication information and often presenting the author's name first name first.

Citing Online Resources and Websites in Psychology

The digital age has made citing online resources a regular part of academic writing. For

psychology research, it's crucial to cite any online material, from journal articles accessed online to organizational websites and reports.

Author-Date System for Online Resources

When citing online resources, the general principle is to provide as much identifying information as possible. This ensures that the reader can always locate the original source, even if URLs change. The DOI is typically formatted as a URL:

- Cherry, Kendra. 2022. "What Is Cognitive Behavioral Therapy?" Verywell Mind. <https://www.verywellmind.com/what-is-cognitive-behavioral-therapy-2795796>. DOI: 10.1037/e56789.

Note that the DOI is usually placed after the page number or at the end of the citation for online journal articles.

Special Considerations for Psychology Bibliographies
