Incorporating Online Resources and Websites

The digital landscape has become an indispensable source of scientific information. Citing online resources accurately in a **chicago style bibliography for sciences** requires attention to URLs and access dates.

General Website Citation

When citing general information from a website, include the author (if available), the title of the specific page or article, the website name, the publication or last updated date (if available), and the URL. When accessing journal articles or data through online databases or platforms, include the information as you would for a print version, followed by the database name and the DOI (Digital Object Identifier) if available, or the URL. The DOI is preferred as it is a persistent link. For the Notes-Bibliography system:

For the Author-Date system:

Specific Considerations for Scientific Data and Software
