Sub-entries for Multiple Works by the Same Author

If you cite multiple works by the same author, they are listed in chronological order of publication within the bibliography. For subsequent works by the same author after the first one, the author's name is replaced by a long dash (—) followed by a comma. For example, if an author has two books published, the first entry will have their full name, and the second entry will begin with the long dash.

Books

If there are three or more authors, list the first author followed by et al. in the in-text citation, but list all authors in the bibliography if the journal specifies. However, for books, the common practice is to list the first author followed by et al. in the bibliography as well, for brevity, especially if there are many authors. The Chicago Manual of Style, 17th edition, prefers listing up to ten authors in the bibliography. For more than ten, the first seven are listed followed by et al.

Example (for more than ten authors):

Johnson, Emily, Robert White, Sarah Green, David Black, Anna Brown, Mark Blue, Karen Gray, Peter Gold, Lisa Silver, Tom Bronze, et al. 2018. *A Comprehensive History of Science*. London: Scholarly Books.

Journal Articles

The format for a journal article is: Author's Last Name, First Name. Year. "Title of Article." Title of Journal Volume (Issue): Page Numbers.

Example:

Williams, Emily. 2022. "The Impact of Digital Media on Literacy." *Journal of Modern Education* 45 (2): 112-130.

If the article is online and has a DOI (Digital Object Identifier):

Taylor, Robert. 2021. "Advancements in Artificial Intelligence." *Artificial Intelligence Quarterly* 10 (3): 45-60. doi:10.1000/aipq.2021.10.3.45.

Websites and Webpages

The format for a webpage is generally: Author's Last Name, First Name (if available). Year. "Title of Webpage." Title of Website. Last modified Date (if available). Accessed Date. URL.

Example:

Brown, Jessica. 2023. "Sustainable Urban Planning." Green Cities Today. Last modified November 15, 2023. Accessed December 1, 2023. <https://www.greencitiestoday.com/urbanplanning>.

If no author is listed, the entry begins with the title of the webpage.

Example (no author):

"Climate Change Projections." National Weather Service. Last modified October 20, 2023. Accessed November 30, 2023. <https://www.weather.gov/climate/projections>.
