Notes-Bibliography System: Examples for Conference Papers

The notes-bibliography system in Chicago style uses numbered footnotes or endnotes to cite sources within the text, with a corresponding bibliography at the end of the work listing all cited sources alphabetically. This system is common in the humanities and some social sciences.

In-Text Notes (Footnotes or Endnotes)

When citing a conference paper in the notes-bibliography system, the initial note for a specific source will include more detail than subsequent notes. Bibliography Entries

The bibliography entry provides a complete, standardized record of the source. For published conference papers, it resembles a book citation. For unpublished papers, it details the presentation itself.

Author-Date System: Examples for Conference Papers

The author-date system uses parenthetical in-text citations that include the author's last name and the year of publication (or presentation), and a reference list at the end of the document that includes full bibliographic information for all cited sources. This system is prevalent in the sciences and some social sciences.

In-Text Citations

In-text citations are brief and appear directly within the text, usually in parentheses, placed after the relevant information and before the final punctuation mark of the sentence or clause.

Example for a published conference paper:

The research indicated a significant correlation between the two variables (Doe 2023, 118).

Alternatively, the author's name can be part of the narrative:

Doe (2023, 118) found a significant correlation between the two variables.

Example for an unpublished conference paper:

The findings suggest a complex interplay between policy and community engagement (Smith 2023).

Reference List Entries

The reference list provides full bibliographic details for each in-text citation, allowing readers to locate the original sources. Entries are alphabetized by the author's last name.

Example for a published conference paper:

Example for an unpublished conference paper:

Citing Published Conference Papers (Proceedings)

When a conference paper has been formally published, typically in a volume of proceedings, it is treated much like a chapter in an edited book or a standalone book, depending on how the proceedings are organized. The key is to identify the book containing the paper and then the specific paper within that collection.

The components to focus on are the paper's title, the title of the proceedings, the editors (if any), the publication information for the proceedings, and the page numbers of the paper. If the proceedings are online, the URL or DOI is essential.

Example for Notes-Bibliography (Bibliography):

Citing Unpublished Conference Papers (Presentations)

Citing a conference paper that was presented but not subsequently published requires a different approach. The focus shifts to documenting the presentation itself as an event. The goal is to provide enough information so that someone who attended the conference (or has access to a recording or abstract) could potentially find or recall the presentation.

The crucial elements are the author, the title of the paper, the name of the conference, the date, and the location of the conference. If the paper is available online as a handout or abstract, that access information should

also be included.

Example for Notes-Bibliography (Bibliography):

Example for Author-Date (Reference List):

Example for an unpublished paper with an abstract available online:

Common Variations and Special Cases

While the core principles remain consistent, several scenarios can arise when citing conference papers, requiring minor adjustments to the standard format. Being aware of these variations helps ensure accuracy in your citations.

Papers presented at a virtual conference: The location should reflect the virtual nature, and if a specific platform was used, it can be noted. The access date is crucial for online materials.

Edited volumes of selected papers: If only a selection of papers from a conference is published, and it's not a full proceedings, the citation will reflect this. This might involve citing it more like a collection of essays.
