Understanding Chicago Style for Edited Books

The Chicago Manual of Style offers two distinct citation systems: the notes-bibliography system and the author-date system. Chicago Style Notes-Bibliography System for Edited Books

Full Note for an Entire Edited Book

Chicago Style Author-Date System for Edited Books

In-Text Citation for an Entire Edited Book

For the author-date system, in-text citations for an entire edited book typically include the editor's last name and the year of publication. If a specific page is being referenced, it is included after the year, often with "p." or "pp.".

Reference List Entry for an Entire Edited Book

The reference list entry in the author-date system for an edited book is similar to the bibliography entry in the notes-bibliography system, but the editor's name is presented

with the last name first, and the year of publication follows immediately after the name.

Citing Multiple Editors

When an edited book has multiple editors, the citation format adjusts to accommodate all contributors. For the notes-bibliography system, "and" is used before the last editor's name in the note. Citing Specific Chapters in Edited Books

When you are referencing a specific chapter or essay within an edited book, the citation must clearly identify both the chapter's author and title, as well as the details of the edited volume in which it appears. This is a common scenario in academic research.

Notes-Bibliography System for a Chapter

In the notes-bibliography system, the citation for a chapter in an edited book includes the chapter author's name, the chapter title in quotation marks, followed by "in," the title of the edited book in italics, the editor's name(s) preceded by "ed.," and then the publication details, including the page numbers where the chapter appears.

Example Reference List Entry:

Brown, Robert. 2020. "The Evolution of the Novel." In *Essays on Modern Literature*, edited by Jane Smith, 78-95. New York: Academic Press.

Common Challenges and Solutions in Chicago Style Citation

Edition Information

When No Editor is Listed

Occasionally, an edited book might be published without explicit editor attribution on the title page. In such cases, if the book is a collection of essays or articles where the content is clearly curated, you might need to search the copyright page or introduction for editorial information. If no editor is evident, you can proceed without this element, but this is a rare occurrence for formally published edited volumes.

Advanced Scenarios in Chicago Style Citation for Edited Books

When Only an Introduction or Preface is Cited

written by someone other than the editor, you will cite it as a chapter or standalone work by that author, with the introduction or preface specified. If the introduction or preface is by the editor, you might cite it as part of the editor's contribution to the book.
