Understanding Chicago Style for Videos

The Chicago Manual of Style: Author-Date System

for Videos

The corresponding entry in the reference list provides full details about the source. This system prioritizes clarity and conciseness within the text itself.

Author-Date: In-Text Citations for Videos

This system allows for more detailed explanatory notes, which can be particularly useful when discussing the context or specific nuances of a video. The bibliography entries mirror the

level of detail found in the author-date system but are formatted differently.

Notes-Bibliography: Footnote/Endnote Citations for Videos

Footnotes or endnotes for videos in the notes-bibliography system provide a quick reference to the source. The first note for a source is typically longer and more detailed than subsequent notes, which can be shortened. A typical first note might include the creator's name, the title of the video, the platform, the publication date, and the URL. For example:

Notes-Bibliography: Bibliography Entries for Videos

The bibliography entry in the notes-bibliography system for a video shares many of the same components as the author-date system but uses a different order and punctuation. The entry begins with the creator's last name, followed by their first name, the title of the video in quotation marks (not italics), the name of the website or platform, and finally, the publication date and URL. Citing YouTube Videos

YouTube is a ubiquitous source of video content, and mastering its citation in Chicago style is essential. The key challenge is often identifying the correct "author." YouTube Videos in Author-Date Style

For author-date, the uploader's name (or channel name) serves as the author. The year of upload is critical. If the video is part of a series with distinct episodes, you may need to cite the specific episode title as well.

YouTube Videos in Notes-Bibliography Style

In the notes-bibliography system, the YouTube uploader's name comes first, followed by the title in quotation marks. Including the channel name and a general description like "YouTube video" is also helpful.

- Alex Kallias. "Understanding the Great Gatsby." YouTube video, 22:00. Posted by Alex Kallias, September 1, 2021. <https://www.youtube.com/watch?v=another-example>.

Remember to always verify the upload date, as this is a crucial piece of information for accurate citation.

Citing Documentaries and Feature Films

Documentaries and feature films, whether watched online or in person, require a slightly different approach than user-generated content. The director is often considered the primary creator, but producers can also be credited. The distributor and release year are also vital components.

Documentaries and Feature Films in Author-Date Style

When citing a documentary or film in author-date style, the director's last name typically functions as the author. The title of the film should be italicized. If you accessed the film online, include the platform and URL.

- Attenborough, David, dir. 2019. *Our Planet: Jungles*. Netflix.
<https://www.netflix.com/title/example>.

Note the inclusion of "dir." after the director's name to indicate their role.

Documentaries and Feature Films in Notes-Bibliography Style

For the notes-bibliography system, the director's name is listed first, followed by the film title in quotation marks. You would then include the distributor and the year of release. The format might look like this:

- Attenborough, David, director. *Our Planet: Jungles*. Produced by Silverback Films, distributed by Netflix, 2019.

If you are citing a specific scene or segment, you would need to note the timestamp in your citation. For online access, include the URL.

Citing Online Lectures and Presentations

Online lectures, webinars, and recorded presentations are increasingly common academic resources. Citing them requires identifying the speaker, the title of the lecture, the institution or platform hosting it, and the date of the presentation or recording.

Online Lectures in Author-Date Style

In the author-date system, the speaker's last name is the author. The title of the lecture should be italicized, followed by the platform and the year of delivery or upload.

Online Lectures in Notes-Bibliography Style

For notes-bibliography, the speaker's name is provided first, followed by the lecture title in quotation marks. You would then include the course name or platform and the date. A sample note might be:

Ensuring you have the correct date of the lecture or presentation is crucial for accurate citation.

A: Including the URL is highly recommended for online videos, as it allows your readers to directly access the source material. In most cases, it is a required element for digital resources in Chicago style.
