Understanding Chicago Style Citation for Tweets

Chicago Style Author-Date System for Tweets

The author-date system in Chicago style, often preferred in the sciences and social sciences, uses parenthetical in-text citations that refer to a reference list at the end of the document. Citing a tweet in this system requires a similar approach to the notes-and-bibliography system, but the in-text citation is more condensed, and the reference list mirrors the bibliography entries from the notes-and-bibliography format.
