- **Author-Date System (Reference List):** Author Last Name, First Name. Year. "Title of Article." Title of Journal Volume, no. Issue: page number(s).

Websites and Online Sources

Citing online sources requires careful attention to available information, including the author (if any), title of the specific page or article, name of the website, the publication or last updated date, and the URL. It is also best practice to include an access date.

Web Pages
