UNDERSTANDING THE PURPOSE OF A CHICAGO STYLE CONCLUDING SENTENCE BODY

THE PRIMARY FUNCTION OF A CHICAGO STYLE CONCLUDING SENTENCE BODY IS TO BRING CLOSURE TO YOUR WORK WHILE SIMULTANEOUSLY REINFORCING ITS MAIN ARGUMENTS AND THESIS. IT'S MORE THAN JUST A SUMMARY; IT'S AN OPPORTUNITY TO OFFER A FINAL PERSPECTIVE, SUGGEST FUTURE IMPLICATIONS, OR PROMPT FURTHER THOUGHT. A WELL-CRAFTED CONCLUSION DEMONSTRATES THAT YOU HAVE THOROUGHLY EXPLORED YOUR TOPIC AND ARRIVED AT A MEANINGFUL UNDERSTANDING. IT ACTS AS A FINAL CONFIRMATION OF YOUR CENTRAL MESSAGE, ENSURING THAT THE READER LEAVES WITH A CLEAR TAKEAWAY. IN ESSENCE, IT'S THE LAST CHANCE TO PERSUADE, INFORM, AND SOLIDIFY YOUR AUTHORIAL VOICE.

WITHIN THE ACADEMIC AND PROFESSIONAL LANDSCAPE, THE CHICAGO MANUAL OF STYLE, OFTEN REFERRED TO AS CMS, PROVIDES GUIDELINES FOR NUMEROUS ASPECTS OF WRITING, INCLUDING THE STRUCTURE AND CONTENT OF CONCLUSIONS. WHILE CMS DOESN'T PRESCRIBE A RIGID FORMULA FOR CONCLUDING SENTENCES, ITS EMPHASIS ON CLARITY, COHERENCE, AND LOGICAL PROGRESSION IMPLIES A NEED FOR A ROBUST AND WELL-REASONED FINAL STATEMENT. THE CONCLUDING SENTENCE BODY SHOULD ECHO THE INTRODUCTION'S PURPOSE WITHOUT MERELY REPEATING IT. IT SHOULD DEMONSTRATE THE SIGNIFICANCE OF THE RESEARCH OR ARGUMENT PRESENTED, HIGHLIGHTING ITS CONTRIBUTION TO THE EXISTING DISCOURSE OR PRACTICAL APPLICATION.

KEY COMPONENTS OF AN EFFECTIVE CONCLUSION

SYNTHESIZING MAIN POINTS

A CRUCIAL ASPECT OF AN EFFECTIVE CHICAGO STYLE CONCLUDING SENTENCE BODY IS THE SYNTHESIS OF THE MAIN POINTS DISCUSSED THROUGHOUT THE PAPER. RESTATING THE THESIS (WITH NEW INSIGHT)

WHILE OUTRIGHT REPETITION OF THE THESIS STATEMENT SHOULD BE AVOIDED, A STRONG CONCLUSION WILL REVISIT AND REFRAME THE CENTRAL ARGUMENT. THIS REPHRASING SHOULD OFFER A NEW PERSPECTIVE OR DEEPER UNDERSTANDING GAINED THROUGH THE EXPLORATION OF THE EVIDENCE. IT DEMONSTRATES THE EVOLUTION OF THOUGHT FROM THE INTRODUCTION TO THE CONCLUSION, SHOWCASING THE JOURNEY THE READER HAS TAKEN WITH YOU. THIS SUBTLE REINFORCEMENT ENSURES THE CORE MESSAGE REMAINS AT THE FOREFRONT OF THE READER'S MIND.

PROVIDING A SENSE OF FINALITY AND CLOSURE

THE CONCLUDING SENTENCE BODY MUST PROVIDE A DEFINITIVE SENSE OF CLOSURE. THIS MEANS BRINGING ALL THREADS OF THE ARGUMENT TO A SATISFYING END. OFFERING A LASTING IMPRESSION OR CALL TO ACTION

DEPENDING ON THE NATURE OF THE WRITING, A CONCLUSION MIGHT ALSO AIM TO LEAVE A LASTING IMPRESSION OR SUGGEST FURTHER AVENUES FOR EXPLORATION OR ACTION. THIS COULD INVOLVE HIGHLIGHTING THE BROADER IMPLICATIONS OF THE RESEARCH, POSING A THOUGHT-PROVOKING QUESTION, OR SUGGESTING PRACTICAL APPLICATIONS. SUCH ELEMENTS CAN ELEVATE THE CONCLUSION FROM A MERE SUMMARY TO A MEMORABLE AND IMPACTFUL STATEMENT, ENCOURAGING CONTINUED ENGAGEMENT WITH THE SUBJECT MATTER.

COMMON MISTAKES TO AVOID

INTRODUCING NEW INFORMATION

ONE OF THE MOST SIGNIFICANT ERRORS IN CRAFTING A CONCLUDING SENTENCE BODY IS INTRODUCING ENTIRELY NEW INFORMATION OR ARGUMENTS THAT WERE NOT PREVIOUSLY DISCUSSED. THE CONCLUSION IS NOT THE PLACE TO PRESENT FRESH EVIDENCE OR DEVELOP NOVEL IDEAS. DOING SO CAN CONFUSE THE READER AND UNDERMINE THE CREDIBILITY OF YOUR ENTIRE PAPER, AS IT SUGGESTS THE ARGUMENT WAS NOT FULLY DEVELOPED WITHIN THE BODY PARAGRAPHS.

BEING TOO VAGUE OR REPETITIVE

CONVERSELY, A CONCLUSION THAT IS TOO VAGUE OR SIMPLY RESTATES THE INTRODUCTION AND MAIN POINTS VERBATIM LACKS IMPACT. WHILE SYNTHESIS IS IMPORTANT, IT NEEDS TO BE PRESENTED WITH CLARITY AND A SENSE OF EVOLVED UNDERSTANDING. GENERIC STATEMENTS THAT OFFER NO NEW INSIGHT OR ARE SO BROAD AS TO BE MEANINGLESS WILL FAIL TO LEAVE A STRONG IMPRESSION. THE AIM IS TO PROVIDE SUBSTANCE, NOT JUST FILLER.

APOLOGIZING FOR LIMITATIONS

AVOID APOLOGIES OR TENTATIVE LANGUAGE REGARDING THE SCOPE OR LIMITATIONS OF YOUR WORK. PHRASES LIKE "I MAY NOT HAVE COVERED EVERYTHING" OR "THIS IS JUST A BRIEF OVERVIEW" CAN WEAKEN YOUR AUTHORITY. A WELL-STRUCTURED ARGUMENT WITHIN ITS STATED SCOPE IS SUFFICIENT. IF LIMITATIONS ARE SIGNIFICANT AND MUST BE MENTIONED, THEY SHOULD BE ADDRESSED CONSTRUCTIVELY WITHIN THE BODY OF THE PAPER.

ENDING ABRUPTLY

A CONCLUSION THAT ENDS ABRUPTLY WITHOUT A SENSE OF COMPLETENESS CAN LEAVE THE READER FEELING UNSATISFIED. THE FINAL SENTENCES SHOULD PROVIDE A SMOOTH TRANSITION TO THE END, OFFERING A SENSE OF RESOLUTION. THIS IS ACHIEVED BY ENSURING THE CONCLUDING THOUGHTS LOGICALLY FOLLOW FROM THE PRECEDING DISCUSSION AND OFFER A SENSE OF FINALITY WITHOUT APPEARING RUSHED.

STRATEGIES FOR STRENGTHENING YOUR CONCLUSION

EMPLOYING A "SO WHAT?" APPROACH

TO STRENGTHEN YOUR CHICAGO STYLE CONCLUDING SENTENCE BODY, CONSIDER THE "SO WHAT?" QUESTION. AFTER SUMMARIZING YOUR FINDINGS, ASK YOURSELF: WHY DOES THIS MATTER? THIS MOVES BEYOND SIMPLE SUMMARY TO DEMONSTRATE THE IMPACT OF YOUR RESEARCH.

USING POWERFUL VERBS AND PRECISE LANGUAGE

THE CHOICE OF WORDS IN YOUR CONCLUSION IS PARAMOUNT. OPT FOR STRONG VERBS AND PRECISE LANGUAGE TO CONVEY YOUR MESSAGE WITH CONVICTION. AVOID PASSIVE VOICE AND WEAK CONSTRUCTIONS. CAREFULLY SELECTED VOCABULARY CAN ELEVATE THE TONE AND ENHANCE THE PERSUASIVENESS OF YOUR FINAL STATEMENTS, ENSURING THEY RESONATE WITH AUTHORITY AND CLARITY. PRECISE LANGUAGE ALSO REINFORCES THE ANALYTICAL RIGOR DEMONSTRATED THROUGHOUT THE PAPER.

CONNECTING BACK TO THE INTRODUCTION

A SOPHISTICATED TECHNIQUE FOR A STRONG CONCLUSION IS TO SUBTLY CONNECT BACK TO THE INTRODUCTION. THIS CAN BE DONE BY REFERENCING A KEY IDEA, A QUOTE, OR A QUESTION POSED AT THE BEGINNING. WHERE APPROPRIATE, A CONCLUSION CAN EFFECTIVELY LOOK TOWARDS THE FUTURE. THIS MIGHT INVOLVE SUGGESTING AREAS FOR FURTHER RESEARCH, ANTICIPATING FUTURE CHALLENGES OR OPPORTUNITIES RELATED TO YOUR TOPIC, OR PROPOSING PRACTICAL APPLICATIONS. THIS FORWARD-LOOKING PERSPECTIVE CAN IMBUE YOUR CONCLUSION WITH A SENSE OF DYNAMISM AND RELEVANCE, SHOWING THE ONGOING IMPORTANCE OF YOUR SUBJECT MATTER.

EXAMPLES OF STRONG AND WEAK CONCLUSIONS

STRONG CONCLUSION EXAMPLE

IN CONCLUSION, THE ANALYSIS OF PRIMARY SOURCE DOCUMENTS REVEALS A SIGNIFICANT SHIFT IN PUBLIC OPINION REGARDING INDUSTRIAL REGULATION IN THE EARLY 20TH CENTURY, DIRECTLY ATTRIBUTABLE TO THE PERSUASIVE POWER OF INVESTIGATIVE JOURNALISM. THIS SHIFT, MOVING FROM TACIT ACCEPTANCE TO ACTIVE DEMAND FOR REFORM, UNDERSCORES THE VITAL ROLE OF AN INFORMED PRESS IN SHAPING DEMOCRATIC DISCOURSE AND ENACTING SUBSTANTIVE POLICY CHANGE. THE

EVIDENCE PRESENTED HERE NOT ONLY CLARIFIES A PIVOTAL MOMENT IN AMERICAN HISTORY BUT ALSO OFFERS A TIMELESS LESSON ON THE ENDURING INFLUENCE OF JOURNALISTIC INTEGRITY IN HOLDING POWER ACCOUNTABLE.

Weak Conclusion Example

THE STRONG EXAMPLE EFFECTIVELY SYNTHESIZES THE MAIN POINTS (SHIFT IN PUBLIC OPINION, INVESTIGATIVE JOURNALISM'S ROLE), RESTATES THE THESIS WITH NEW INSIGHT (JOURNALISTIC INTEGRITY IN HOLDING POWER ACCOUNTABLE), PROVIDES A SENSE OF FINALITY, AND OFFERS A LASTING IMPRESSION (TIMELESS LESSON). THE WEAK EXAMPLE, HOWEVER, IS VAGUE, REPETITIVE, LACKS SYNTHESIS, AND ENDS ABRUPTLY WITHOUT IMPACT.

The Role of Tone and Voice in the Final Sentences

THE TONE AND VOICE ADOPTED IN THE CHICAGO STYLE CONCLUDING SENTENCE BODY ARE CRITICAL FOR REINFORCING THE OVERALL MESSAGE AND AUTHORIAL CREDIBILITY. THIS DOES NOT MEAN BEING OVERLY ASSERTIVE OR DOGMATIC, BUT RATHER DEMONSTRATING A CLEAR UNDERSTANDING OF THE SUBJECT MATTER AND A FIRM GRASP ON THE EVIDENCE PRESENTED. THIS PROFESSIONAL DEemeanOR IS A HALLMARK OF EFFECTIVE ACADEMIC AND PROFESSIONAL WRITING UNDER THE CHICAGO MANUAL OF STYLE.

Chicago Style Concluding Sentence Body in Different Contexts

Academic Papers

IN ACADEMIC PAPERS ADHERING TO CHICAGO STYLE, THE CONCLUDING SENTENCE BODY TYPICALLY SUMMARIZES KEY FINDINGS, REITERATES THE THESIS IN A REFINED MANNER, AND DISCUSSES THE BROADER IMPLICATIONS OR SIGNIFICANCE OF THE RESEARCH. IT MIGHT ALSO SUGGEST AVENUES FOR FUTURE STUDY, THEREBY CONTRIBUTING TO THE ONGOING SCHOLARLY CONVERSATION. THE EMPHASIS IS ON ANALYTICAL RIGOR AND SCHOLARLY CONTRIBUTION.

IT SUMMARIZES THE MAIN FINDINGS AND THEIR RELEVANCE TO THE PROBLEM STATEMENT OR OBJECTIVES. RECOMMENDATIONS FOR FUTURE ACTION OR POLICY ARE COMMON IN THIS CONTEXT, AIMING TO PROVIDE CLEAR GUIDANCE BASED ON THE RESEARCH OUTCOMES.

Essays and Dissertations

ESSAYS AND DISSERTATIONS, WHILE SIMILAR TO ACADEMIC PAPERS, MAY ALLOW FOR A SLIGHTLY MORE PERSONAL REFLECTION OR A STRONGER PERSUASIVE ELEMENT IN THEIR CONCLUDING SENTENCE BODY, DEPENDING ON THE DISCIPLINARY CONVENTIONS.

HOWEVER, THE CORE PRINCIPLES OF SYNTHESIS, REINFORCEMENT OF THE THESIS, AND PROVIDING CLOSURE REMAIN PARAMOUNT. THE CONCLUSION SHOULD DEMONSTRATE THE STUDENT'S MASTERY OF THE SUBJECT AND THEIR ABILITY TO ARTICULATE A COHERENT ARGUMENT.

BEST PRACTICES FOR REVISING AND EDITING

A: TO ENSURE A LOGICAL FLOW, REREAD THE LAST PARAGRAPH OF YOUR BODY BEFORE YOU BEGIN WRITING YOUR CONCLUSION. THEN, START BY SYNTHESIZING THE KEY ARGUMENTS THAT LED TO THAT FINAL POINT, GRADUALLY BROADENING OUT TO THE OVERALL SIGNIFICANCE OF YOUR THESIS.
