UNDERSTANDING THE PURPOSE OF A CONCLUSION

BROADENING THE SCOPE AND OFFERING FINAL THOUGHTS

A TRULY EXCEPTIONAL CHICAGO STYLE CONCLUSION GOES BEYOND SUMMARIZING TO BROADEN THE SCOPE OF YOUR DISCUSSION. THIS INVOLVES REFLECTING ON THE LARGER IMPLICATIONS OR SIGNIFICANCE OF YOUR RESEARCH. - OFFERING AN APOLOGY OR EXPRESSING DOUBT ABOUT YOUR FINDINGS.
- ENDING ABRUPTLY WITHOUT A SENSE OF CLOSURE.
- USING CLICHE² PHRASES LIKE "IN CONCLUSION" OR "TO SUM UP."
- MAKING SWEEPING GENERALIZATIONS NOT SUPPORTED BY THE BODY OF THE PAPER.

AVOIDING THESE MISTAKES WILL ENSURE THAT YOUR CONCLUSION ACTS AS A STRONG FINAL STATEMENT, RATHER THAN A WEAKNESS IN YOUR OVERALL PAPER.

TIPS FOR WRITING A POWERFUL CHICAGO STYLE CONCLUSION

A POLISHED CONCLUSION IS OFTEN THE RESULT OF CAREFUL REVISION.

FINAL REMARKS ON CONCLUDING YOUR ENGLISH PAPER

Q: HOW LONG SHOULD A CHICAGO STYLE CONCLUSION FOR AN ENGLISH PAPER TYPICALLY BE?

Q: HOW CAN I EFFECTIVELY BROADEN THE SCOPE OF MY CHICAGO STYLE CONCLUSION?
