A CORRESPONDING BIBLIOGRAPHY AT THE END OF THE PAPER LISTS ALL CITED SOURCES ALPHABETICALLY BY AUTHOR'S LAST NAME.

THE BIBLIOGRAPHY ENTRIES THEMSELVES REQUIRE SPECIFIC FORMATTING FOR VARIOUS SOURCE TYPES, INCLUDING JOURNAL ARTICLES, BOOKS, BOOK CHAPTERS, WORKING PAPERS, AND ONLINE RESOURCES. FOR JOURNAL ARTICLES, A TYPICAL ENTRY MIGHT LOOK LIKE: AUTHOR, FIRST NAME. YEAR. "ARTICLE TITLE." *JOURNAL TITLE* VOLUME (ISSUE): PAGE NUMBERS. FOR ECONOMICS, IT'S CRUCIAL TO INCLUDE THE DOI (DIGITAL OBJECT IDENTIFIER) IF AVAILABLE, AS THIS PROVIDES A PERSISTENT LINK TO THE ARTICLE.
