Anonymous Books in Footnotes/Endnotes

When an anonymous book is referenced in a footnote or endnote, the format generally begins with the title, followed by the publication information. Citing Anonymous Articles and Periodicals

Anonymous Articles in Footnotes/Endnotes

For articles in periodicals where the author is not identified, the citation begins with the article title, enclosed in quotation marks, followed by the periodical title (italicized) and the publication details. Again, page numbers are essential for direct quotes or specific references.

Anonymous Articles in the Bibliography

In the bibliography, the entry for an anonymous article starts with the article title in quotation marks. The periodical title follows, italicized, along with the volume, issue number, date, and page range. The entry will be alphabetized by the first significant word of the article title.

Anonymous Online Sources in Footnotes/Endnotes

For anonymous web pages or articles, the citation in the notes begins with the title of the page or article in quotation marks, followed by the website name (if distinct from the title), and the URL. The date of publication or last update, if available, is also included. A retrieval date is often necessary for online sources that may change.

Anonymous Online Sources in the Bibliography

The bibliography entry for an anonymous online source will start with the title of the webpage or article in quotation marks. (no date) for the publication date and provide the retrieval date.
