The shortened note for online sources typically omits the access date unless the content is particularly volatile.

Editions and Reprints

If you are citing a specific edition of a magazine that is not the most current, or if you are referencing an article that has been reprinted, you will need to include this information in your citation. However, for most standard magazine articles, this is less common than for books.
