Foreign Patents

Handling Variations in Patent Information

Patent Applications vs. Issued Patents

When the Inventor's Name is Not Clear or Multiple Inventors are Listed

In cases where there are numerous inventors, or the primary inventor is not immediately obvious, follow the patent document's lead. If the patent lists many inventors, you may be able to cite the first inventor followed by "et al." However, always check specific Chicago style editions or consult with your instructor or editor, as best practice can vary. For the purpose of this guide, listing all is preferred when feasible.

Including Abstract or Claims

While not always mandatory, for highly technical or specific references, you might choose to cite a particular claim or the abstract of the patent. If you do this, ensure it is clearly indicated within the footnote.

Subsequent Citations of Patents

Once a patent has been cited in a footnote, subsequent citations within the same work are handled differently for brevity, following standard Chicago style practices for shortened citations.

Shortened Footnote Citations

For subsequent references to the same patent, a shortened form of the footnote is used. This typically includes the inventor's last name, a shortened version of the patent title, and the patent number. This saves space and avoids redundancy.

- Smith, "Improved Widget," U.S. Patent No. 10,123,456.

This shortened format allows the reader to quickly identify which patent is being referenced without repeating all the initial details. It is imperative that the shortened title clearly identifies the patent.

Subsequent Citations with Different Page Numbers
