Understanding the Chicago Manual of Style

The Author-Date System

The Author-Date system, on the other hand, employs parenthetical in-text citations that include the author's last name and the year of publication, along with page numbers if a specific passage is being quoted or paraphrased. Correspondingly, a reference list is provided at the end of the document, listing all cited sources alphabetically by author's last name. This system is generally more common in the sciences and some social sciences because it allows readers to quickly identify the source and publication date of information directly within the text, facilitating a chronological understanding of research development, which can be beneficial when examining the evolution of thought on environmental issues.

Core Elements of Chicago Style Citations for Environmental Sociology

Regardless of the chosen system, certain core bibliographic elements are fundamental to creating accurate Chicago style citations for environmental sociology research. These elements help readers identify and locate the source material unequivocally. Accuracy in these details is paramount for scholarly credibility.

Key components typically include:

- Author(s) name(s)

- Title of the work (article, book, report, etc.)

In-Text Citations for the Notes-Bibliography System

When using the Notes-Bibliography system, superscript numbers are placed immediately after the relevant phrase, clause, or sentence, before any punctuation. These numbers correspond to notes (either footnotes at the bottom of the page or endnotes at the end of the chapter or work). The first time a source is cited in a note, the full bibliographic details are provided. Subsequent citations of the same source use a shortened form, typically including the author's last name, a shortened title, and the page number.

For example:

The social construction of environmental problems often influences policy responses.¹ Later, the same source might be cited as:² Smith, "Ecological Modernization," 45.

In-Text Citations for the Author-Date System

The Author-Date system uses parenthetical citations. These citations appear within the text, usually at the end of a sentence or clause, and typically include the author's last name, the year of publication, and the page number(s) if referencing specific material. This format is concise and allows for quick retrieval of source information.

For example:

Research indicates a strong correlation between industrial pollution and community health disparities (Jones 2018, 112). If the author's name is mentioned in the text, only the year and page number are needed in the parentheses: As Jones (2018) argues, the connection is undeniable (112).

Creating a Bibliography in Chicago Style

The bibliography or reference list is a crucial component of any Chicago-style paper, providing a comprehensive inventory of all sources consulted and cited. The format differs slightly between the two systems, but the goal remains the same: to offer complete and accurate information for each source.

Bibliography for the Notes-Bibliography System

The bibliography for the Notes-Bibliography system is an alphabetical list of all works cited in the text. Each entry begins with the author's last name, followed by their first name. Titles of books are italicized, and titles of articles or chapters are enclosed in quotation marks. Publication details, including the publisher and year, are included. Unlike the notes, the bibliography entry does not include page numbers of the source itself, but rather the entire publication's details.

Reference List for the Author-Date System

The reference list for the Author-Date system is also an alphabetical list of all works cited. The primary distinction from a Notes-Bibliography bibliography is that the author's last name is followed by their first name, and the year of publication immediately follows the author's name, often in parentheses. Book titles are italicized, and article or chapter titles are in quotation marks. This immediate placement of the publication year is characteristic of this system.

Citing Common Environmental Sociology Sources

Environmental sociology draws on a wide array of sources, each requiring specific formatting within Chicago style. Understanding how to cite these diverse materials is essential for accurate and comprehensive research documentation.

Journal Articles

Journal articles are a staple in environmental sociology. When citing them, precision regarding author(s), article title, journal title, volume, issue, year, and page numbers (and DOI if available) is critical.

Books

Books provide foundational theories and in-depth analyses in environmental sociology. Proper citation involves author, title, publication location, publisher, and year.

Government Reports and Publications

Interviews

Primary research in environmental sociology often involves interviews. These

are typically cited in notes only (not in the bibliography or reference list) unless they are formally published or widely accessible. If cited, include the interviewee's name, the date of the interview, and the method of delivery (e.g., personal interview, email interview).

Notes-Bibliography Example:

1. Interview with Dr. Maria Rodriguez, environmental sociologist, by the author, October 15, 2023, personal interview.

Author-Date Example:

In discussions about community resilience, local leaders emphasized adaptive strategies (Rodriguez, personal interview, October 15, 2023).

The Importance of Consistency in Chicago Style

A: Yes, Chicago style does provide guidance for citing blogs and social media. For personal interviews conducted via social media, it's often treated like a personal interview, mentioned in notes and not a formal bibliography.
