Understanding the Two Chicago Style Systems

The Chicago Manual of Style (CMOS) presents writers with two primary methods for incorporating in-text citations: the notes-bibliography system and the author-date system. The Notes–Bibliography System: Footnotes and Endnotes

Citing Books with Footnotes/Endnotes

The place of publication, publisher, and year of publication are enclosed in parentheses, followed by a comma and the page number(s) being cited. For example, a first citation might look like this: 1. Jane Doe, *The History of Citation Styles* (New York: Academic Press, 2020), 45.

Citing Journal Articles with Footnotes/Endnotes

For journal articles, the footnote or endnote citation includes the author's first name and last name, the title of the article in quotation marks, the title of the journal in italics, followed by the volume number, issue number (if applicable), year of publication in parentheses, and the page number(s). For instance: 2. John Smith, "The Evolution of Academic Writing," *Journal of Scholarly Practice* 15, no. 2 (2019):

112. Note the use of commas and parentheses to delineate different components of the citation.

Citing Websites and Online Articles with Footnotes/Endnotes

Citing online sources requires careful attention to detail. For websites or online articles, include the author's name (if available), the title of the page or article in quotation marks, the name of the website in italics, the publication date (or last updated date), and the URL. The Author-Date System: Parenthetical Citations

The author-date system, also known as the parenthetical citation system, places brief citations directly within the text, typically in parentheses. These parenthetical citations include the author's last name and the year of publication, and often the page number(s) if a specific point is being referenced. This system is prevalent in the natural and social sciences, where it is crucial to quickly identify the source and date of information to assess its currency and relevance.

When to Use the Author-Date System

The author-date system is favored in fields that prioritize the chronological development of ideas and research. Citing Websites and Online Articles with Parenthetical Citations

ibid. and Subsequent Citations

If footnote 6 cites the same source but a different page number, it would be "Ibid., 50." This practice streamlines the citation process and reduces redundancy.
