## Formatting Websites and Online Sources

For websites, include the author or organization responsible, the title of the specific page or article, the website name (if distinct from the author), the publication or last updated date (if available), and the URL. For the Notes and Bibliography system: Author/Organization. "Page Title." Website Name. Publication Date or Last Updated. Accessed Month Day, Year. URL.

For the Author-Date system: Author/Organization. Year of Publication (or n.d. if no date). "Page Title." Website Name. Publication Date or Last Updated. Accessed Month Day, Year. URL.

## Formatting Other Source Types

Chicago style also provides guidelines for a wide array of other source types commonly encountered in research. This includes book chapters, dissertations, conference proceedings, interviews, films, and government documents. Each requires a specific format to capture all essential bibliographic details.
