UNDERSTANDING THE PURPOSE OF A HUMANITIES ABSTRACT

THE PRIMARY PURPOSE OF A CHICAGO-STYLE HUMANITIES ABSTRACT IS TO PROVIDE A CONCISE, SELF-CONTAINED SUMMARY OF YOUR RESEARCH. IT ACTS AS A VITAL TOOL FOR READERS, HELPING THEM QUICKLY ASCERTAIN THE RELEVANCE AND SIGNIFICANCE OF YOUR WORK WITHOUT HAVING TO READ THE ENTIRE PAPER. IN ACADEMIC CONFERENCES, JOURNALS, AND DATABASES, THE ABSTRACT IS OFTEN THE FIRST POINT OF CONTACT A SCHOLAR HAS WITH YOUR RESEARCH, MAKING ITS CLARITY AND ACCURACY INDISPENSABLE.

BEYOND MERE SUMMARIZATION, A WELL-CRAFTED ABSTRACT ENTICES POTENTIAL READERS, SIGNALING THE CENTRAL ARGUMENT, METHODOLOGY, AND FINDINGS OF YOUR STUDY. FOR HUMANITIES RESEARCH, THIS MEANS EFFECTIVELY COMMUNICATING THE THEORETICAL FRAMEWORK, THE SPECIFIC TEXTS OR ARTIFACTS ANALYZED, AND THE SCHOLARLY CONTRIBUTION YOUR WORK AIMS TO MAKE. IT'S A MINIATURE ADVERTISEMENT FOR YOUR SCHOLARSHIP, DESIGNED TO PIQUE INTELLECTUAL CURIOSITY AND ENCOURAGE DEEPER ENGAGEMENT.

KEY COMPONENTS OF A CHICAGO STYLE HUMANITIES ABSTRACT

A STANDARD CHICAGO-STYLE HUMANITIES ABSTRACT TYPICALLY COMPRISES SEVERAL ESSENTIAL ELEMENTS THAT WORK IN CONCERT TO PRESENT A COMPLETE PICTURE OF YOUR RESEARCH. THESE COMPONENTS, WHILE FLUID IN THEIR ORDER OF PRESENTATION DEPENDING ON THE SPECIFIC EMPHASIS, ARE FUNDAMENTAL TO A ROBUST ABSTRACT.

PROBLEM STATEMENT OR RESEARCH QUESTION

FOR HUMANITIES SCHOLARS, THIS MIGHT INVOLVE QUESTIONING A LONG-HELD INTERPRETATION, EXPLORING AN UNDER-EXAMINED CULTURAL PHENOMENON, OR RE-EVALUATING A KEY HISTORICAL EVENT OR LITERARY TEXT.

METHODOLOGY OR APPROACH

NEXT, BRIEFLY DESCRIBE THE METHODOLOGY OR APPROACH YOU HAVE EMPLOYED. IN THE HUMANITIES, THIS CAN BE DIVERSE, RANGING FROM CLOSE READING AND TEXTUAL ANALYSIS TO ARCHIVAL RESEARCH, CULTURAL CRITICISM, OR THEORETICAL ENGAGEMENT. CLEARLY STATING YOUR METHODS ASSURES READERS OF THE SCHOLARLY RIGOR UNDERPINNING YOUR INVESTIGATION.

KEY FINDINGS OR ARGUMENTS

THE CORE OF YOUR ABSTRACT LIES IN PRESENTING YOUR MAIN FINDINGS OR CENTRAL ARGUMENTS. THIS SECTION SHOULD SUCCINCTLY CONVEY THE CONCLUSIONS DRAWN FROM YOUR RESEARCH AND THE SIGNIFICANT INSIGHTS YOU HAVE UNCOVERED. AVOID JARGON WHERE POSSIBLE, BUT ENSURE THAT THE CORE OF YOUR INTELLECTUAL CONTRIBUTION IS EVIDENT.

SIGNIFICANCE AND CONTRIBUTION

FINALLY, ARTICULATE THE BROADER SIGNIFICANCE AND SCHOLARLY CONTRIBUTION OF YOUR WORK. HOW DOES YOUR RESEARCH ADVANCE THE FIELD? WHAT NEW PERSPECTIVES DOES IT OFFER? THIS ELEMENT UNDERSCORES THE VALUE AND IMPACT OF YOUR STUDY, ENCOURAGING READERS TO SEE ITS PLACE WITHIN THE WIDER ACADEMIC CONVERSATION.

STRUCTURING YOUR CHICAGO STYLE HUMANITIES ABSTRACT

THE STRUCTURE OF YOUR ABSTRACT, WHILE NOT AS RIGIDLY DEFINED AS THE CHICAGO MANUAL OF STYLE'S CITATION GUIDELINES, FOLLOWS A LOGICAL PROGRESSION THAT ENHANCES CLARITY AND IMPACT. A COMMON AND EFFECTIVE STRUCTURE ENSURES THAT ALL NECESSARY INFORMATION IS PRESENTED IN AN ORGANIZED AND DIGESTIBLE MANNER.

OPENING WITH CONTEXT

THE ABSTRACT SHOULD COMMENCE WITH A SENTENCE OR TWO THAT ESTABLISHES THE RESEARCH AREA AND THE SPECIFIC PROBLEM OR QUESTION BEING INVESTIGATED. THIS IMMEDIATELY GROUNDS THE READER AND SIGNALS THE FOCUS OF YOUR STUDY. FOR INSTANCE, YOU MIGHT START BY STATING THE PREVAILING SCHOLARLY CONSENSUS YOU ARE CHALLENGING OR THE PARTICULAR HISTORICAL PERIOD YOU ARE EXAMINING.

ELABORATING ON THE CORE INQUIRY

FOLLOWING THE INITIAL CONTEXT, ELABORATE ON THE RESEARCH QUESTION OR HYPOTHESIS. THIS IS WHERE YOU CLEARLY STATE WHAT YOU AIM TO DISCOVER OR ARGUE. FOR A LITERARY ANALYSIS, THIS MIGHT BE A SPECIFIC INTERPRETATION OF A MOTIF; FOR HISTORICAL RESEARCH, IT COULD BE A RE-EXAMINATION OF A PARTICULAR CAUSE AND EFFECT.

DETAILING THE RESEARCH PROCESS

SUBSEQUENTLY, DEDICATE A PORTION OF THE ABSTRACT TO OUTLINING YOUR RESEARCH METHODOLOGY. THIS IS NOT AN

EXHAUSTIVE DESCRIPTION BUT RATHER A SUMMARY OF THE KEY TECHNIQUES OR THEORETICAL LENSES EMPLOYED. EXAMPLES INCLUDE HERMENEUTIC ANALYSIS, POSTCOLONIAL THEORY APPLICATION, OR COMPARATIVE HISTORICAL METHODOLOGIES.

PRESENTING THE OUTCOMES

THE PENULTIMATE PART OF THE ABSTRACT SHOULD REVEAL YOUR PRIMARY FINDINGS OR THE ESSENCE OF YOUR ARGUMENT. WHAT ARE THE MOST IMPORTANT CONCLUSIONS YOU HAVE REACHED? THIS SHOULD BE PRESENTED CONCISELY AND DIRECTLY, HIGHLIGHTING THE NOVEL ASPECTS OF YOUR INSIGHTS.

CONCLUDING WITH IMPACT

CONCLUDE YOUR ABSTRACT BY EMPHASIZING THE SIGNIFICANCE OF YOUR RESEARCH. HOW DOES IT CONTRIBUTE TO EXISTING KNOWLEDGE, AND WHAT IMPLICATIONS DOES IT HAVE FOR FUTURE SCHOLARSHIP OR UNDERSTANDING? THIS FINAL STATEMENT SHOULD LEAVE THE READER WITH A CLEAR APPRECIATION OF YOUR WORK'S VALUE.

CRAFTING COMPELLING CONTENT FOR YOUR ABSTRACT

THE EFFECTIVENESS OF A CHICAGO-STYLE HUMANITIES ABSTRACT HINGES ON THE CLARITY, CONCISENESS, AND COMPELLING NATURE OF ITS CONTENT. EVERY WORD COUNTS, AND THE INFORMATION PRESENTED MUST BE BOTH ACCURATE AND ENGAGING. THIS REQUIRES CAREFUL SELECTION OF DETAILS AND A FOCUS ON THE MOST IMPACTFUL ASPECTS OF YOUR RESEARCH.

FOCUS ON THE CORE ARGUMENT

ENSURE THAT YOUR CENTRAL ARGUMENT OR THESIS IS CLEARLY IDENTIFIABLE WITHIN THE ABSTRACT. READERS SHOULD UNDERSTAND PRECISELY WHAT YOU ARE ASSERTING OR DEMONSTRATING. AVOID GETTING BOGGED DOWN IN MINOR DETAILS OR TANGENTIAL POINTS; THE ABSTRACT IS FOR THE OVERARCHING NARRATIVE OF YOUR RESEARCH.

HIGHLIGHTING ORIGINALITY

IN ACADEMIC WRITING, ORIGINALITY IS PARAMOUNT. YOUR ABSTRACT SHOULD SUBTLY, OR EXPLICITLY, CONVEY WHAT IS NEW ABOUT YOUR RESEARCH. ARE YOU OFFERING A NOVEL INTERPRETATION, UNCOVERING PREVIOUSLY UNEXAMINED EVIDENCE, OR APPLYING A NEW THEORETICAL FRAMEWORK TO AN ESTABLISHED TOPIC? EMPHASIZE THIS DISTINCTIVE CONTRIBUTION.

DEMONSTRATING SCHOLARLY RIGOR

WHILE CONCISE, THE ABSTRACT MUST ALSO CONVEY THE INTELLECTUAL DEPTH AND RIGOR OF YOUR STUDY. MENTIONING KEY THEORETICAL INFLUENCES, SIGNIFICANT PRIMARY SOURCES, OR THE SPECIFIC ANALYTICAL TECHNIQUES USED CAN SUBTLY SIGNAL THE SOPHISTICATED NATURE OF YOUR WORK, EVEN WITHOUT DELVING INTO METHODOLOGICAL MINUTIAE.

USING PRECISE LANGUAGE

EMPLOY PRECISE AND UNAMBIGUOUS LANGUAGE. HUMANITIES RESEARCH OFTEN DEALS WITH COMPLEX CONCEPTS, BUT THE ABSTRACT SHOULD STRIVE FOR ACCESSIBILITY. DEFINE SPECIALIZED TERMS IF THEY ARE ESSENTIAL AND UNAVOIDABLE, BUT PRIORITIZE CLARITY AND DIRECTNESS IN CONVEYING YOUR IDEAS TO A POTENTIALLY DIVERSE ACADEMIC AUDIENCE.

LANGUAGE AND TONE IN HUMANITIES ABSTRACTS

THE LANGUAGE AND TONE EMPLOYED IN YOUR ABSTRACT SIGNIFICANTLY INFLUENCE HOW YOUR RESEARCH IS PERCEIVED. A PROFESSIONAL, AUTHORITATIVE, AND ENGAGING TONE IS CRUCIAL FOR ATTRACTING SCHOLARLY ATTENTION AND ESTABLISHING CREDIBILITY.

PROFESSIONALISM AND AUTHORITY

MAINTAIN A FORMAL AND PROFESSIONAL TONE THROUGHOUT THE ABSTRACT. AVOID COLLOQUIALISMS, SLANG, OR OVERLY CASUAL LANGUAGE. THE OBJECTIVE IS TO PRESENT YOUR RESEARCH AS A SERIOUS ACADEMIC ENDEAVOR, REFLECTING THE SCHOLARLY STANDARDS OF THE HUMANITIES.

CLARITY AND CONCISENESS

PRIORITIZE CLARITY ABOVE ALL ELSE. USE DIRECT SENTENCES AND AVOID UNNECESSARY JARGON OR OVERLY COMPLEX SENTENCE STRUCTURES. CONCISENESS IS KEY; EVERY WORD SHOULD SERVE A PURPOSE IN CONVEYING ESSENTIAL INFORMATION ABOUT YOUR RESEARCH. AIM TO BE INFORMATIVE WITHOUT BEING VERBOSE.

ENGAGING THE READER

WHILE MAINTAINING PROFESSIONALISM, YOUR ABSTRACT SHOULD ALSO BE ENGAGING. USE ACTIVE VOICE AND STRONG VERBS TO CONVEY YOUR ARGUMENTS AND FINDINGS DYNAMICALLY. THE GOAL IS TO SPARK INTELLECTUAL CURIOSITY, ENCOURAGING READERS TO DELVE DEEPER INTO YOUR WORK.

AVOIDING SUBJECTIVITY

AS A SCHOLARLY SUMMARY, THE ABSTRACT SHOULD REMAIN OBJECTIVE. WHILE YOU ARE PRESENTING YOUR OWN FINDINGS AND ARGUMENTS, THE PRESENTATION SHOULD BE GROUNDED IN EVIDENCE AND ANALYSIS, RATHER THAN PERSONAL OPINION OR UNSUBSTANTIATED CLAIMS. LET YOUR RESEARCH SPEAK FOR ITSELF THROUGH A CLEAR AND OBJECTIVE PRESENTATION.

COMMON MISTAKES TO AVOID IN CHICAGO STYLE ABSTRACT WRITING

MANY SCHOLARS, PARTICULARLY THOSE NEW TO ACADEMIC WRITING OR ABSTRACT PREPARATION, CAN FALL INTO COMMON TRAPS THAT DIMINISH THE EFFECTIVENESS OF THEIR CHICAGO-STYLE HUMANITIES ABSTRACTS. RECOGNIZING THESE PITFALLS IS THE FIRST STEP TOWARD CRAFTING SUPERIOR SUMMARIES.

- OVERLY TECHNICAL JARGON WITHOUT EXPLANATION.
- INCLUDING LENGTHY BACKGROUND INFORMATION NOT DIRECTLY RELEVANT TO THE CORE RESEARCH.
- FAILING TO CLEARLY STATE THE RESEARCH QUESTION OR THESIS.
- OMITTING A DESCRIPTION OF THE METHODOLOGY OR ANALYTICAL APPROACH.
- MAKING GRAND CLAIMS ABOUT FINDINGS THAT ARE NOT SUPPORTED BY THE ABSTRACT'S SUMMARY.
- EXCEEDING THE SPECIFIED WORD COUNT, LEADING TO DILUTION OF KEY INFORMATION.
- USING PASSIVE VOICE EXCESSIVELY, WHICH CAN MAKE SENTENCES LESS DIRECT AND IMPACTFUL.

- FORGETTING TO INCLUDE A STATEMENT ABOUT THE SIGNIFICANCE OR CONTRIBUTION OF THE RESEARCH.

THESE ERRORS CAN OBSCURE THE VALUE OF YOUR WORK, DETER POTENTIAL READERS, AND MISREPRESENT THE SCOPE AND DEPTH OF YOUR SCHOLARSHIP. DILIGENT REVISION CAN HELP TO ELIMINATE THESE ISSUES.

THE ROLE OF KEYWORDS IN ABSTRACT OPTIMIZATION

KEYWORDS ARE ESSENTIAL FOR THE DISCOVERABILITY OF YOUR RESEARCH WITHIN ACADEMIC DATABASES AND SEARCH ENGINES. FOR A CHICAGO-STYLE HUMANITIES ABSTRACT, SELECTING APPROPRIATE KEYWORDS SIGNIFICANTLY ENHANCES ITS VISIBILITY TO SCHOLARS SEARCHING FOR RELEVANT TOPICS.

IDENTIFYING CORE CONCEPTS

CAREFULLY IDENTIFY THE CENTRAL CONCEPTS, THEORIES, AUTHORS, TEXTS, HISTORICAL PERIODS, AND METHODOLOGIES THAT ARE INTEGRAL TO YOUR RESEARCH. THESE FORM THE FOUNDATION FOR YOUR KEYWORD SELECTION.

USING SPECIFIC AND BROAD TERMS

EMPLOY A MIX OF SPECIFIC AND BROADER TERMS. SPECIFIC TERMS PINPOINT THE PRECISE FOCUS OF YOUR WORK (E.G., "VICTORIAN POETRY ANALYSIS," "EARLY MODERN ECONOMIC HISTORY"), WHILE BROADER TERMS CAN CAPTURE A WIDER AUDIENCE INTERESTED IN RELATED FIELDS (E.G., "LITERARY STUDIES," "HISTORICAL METHODOLOGIES").

CONSIDERING SYNONYMS AND RELATED TERMS

THINK ABOUT SYNONYMS AND RELATED TERMS THAT SCHOLARS MIGHT USE WHEN SEARCHING FOR INFORMATION SIMILAR TO YOURS. INCLUDING THESE VARIATIONS CAN BROADEN THE REACH OF YOUR ABSTRACT.

CONSULTING JOURNAL GUIDELINES

MANY JOURNALS AND CONFERENCE ORGANIZERS PROVIDE GUIDELINES ON THE NUMBER AND TYPES OF KEYWORDS THEY PREFER. ALWAYS CONSULT THESE GUIDELINES TO ENSURE YOUR SELECTION ALIGNS WITH THEIR REQUIREMENTS AND TO MAXIMIZE YOUR ABSTRACT'S PLACEMENT IN THEIR SYSTEMS.

FINAL REVIEW AND REFINEMENT OF YOUR ABSTRACT

THE PROCESS OF WRITING A CHICAGO-STYLE HUMANITIES ABSTRACT IS ITERATIVE. A THOROUGH FINAL REVIEW AND REFINEMENT STAGE IS CRUCIAL TO ENSURE IT IS POLISHED, ACCURATE, AND EFFECTIVE. THIS STEP INVOLVES MULTIPLE CHECKS TO CATCH ERRORS AND IMPROVE CLARITY.

PROOFREADING FOR ERRORS

METICULOUSLY PROOFREAD FOR ANY GRAMMATICAL ERRORS, TYPOS, OR PUNCTUATION MISTAKES. EVEN MINOR ERRORS CAN DETRACT FROM THE PROFESSIONALISM OF YOUR ABSTRACT AND CAST DOUBT ON THE METICULOUSNESS OF YOUR RESEARCH.

CHECKING FOR CLARITY AND FLOW

READ YOUR ABSTRACT ALOUD TO ASSESS ITS FLOW AND CLARITY. DOES IT MOVE LOGICALLY FROM ONE POINT TO THE NEXT? ARE THE SENTENCES EASY TO UNDERSTAND? ENSURE THAT THE CENTRAL ARGUMENT IS UNMISTAKABLE AND THAT THE SUMMARY PROVIDES A COHERENT OVERVIEW OF YOUR WORK.

VERIFYING ACCURACY

CONFIRM THAT THE ABSTRACT ACCURATELY REFLECTS THE CONTENT OF YOUR FULL PAPER. ENSURE THAT THE CLAIMS MADE IN THE ABSTRACT ARE SUBSTANTIATED BY YOUR RESEARCH AND THAT NO INFORMATION IS MISREPRESENTED OR EXAGGERATED.

ADHERING TO LENGTH REQUIREMENTS

MOST JOURNALS AND CONFERENCES HAVE STRICT WORD LIMITS FOR ABSTRACTS. DOUBLE-CHECK THAT YOUR ABSTRACT ADHERES TO THESE REQUIREMENTS. IF IT IS TOO LONG, IDENTIFY AREAS WHERE YOU CAN CONDENSE INFORMATION WITHOUT SACRIFICING ESSENTIAL CONTENT. IF IT IS TOO SHORT, CONSIDER WHETHER ANY CRUCIAL ELEMENTS ARE MISSING.

SEEKING FEEDBACK

IF POSSIBLE, HAVE A COLLEAGUE OR MENTOR REVIEW YOUR ABSTRACT. AN EXTERNAL PERSPECTIVE CAN OFTEN IDENTIFY AREAS FOR IMPROVEMENT THAT YOU MIGHT HAVE OVERLOOKED. THEY CAN OFFER VALUABLE INSIGHTS INTO CLARITY, CONCISENESS, AND OVERALL IMPACT.

FAQ SECTION

Q: WHAT IS THE TYPICAL WORD COUNT FOR A CHICAGO-STYLE HUMANITIES ABSTRACT?

A: WHILE SPECIFIC REQUIREMENTS CAN VARY BY JOURNAL OR CONFERENCE, A TYPICAL WORD COUNT FOR A CHICAGO-STYLE HUMANITIES ABSTRACT RANGES FROM 150 TO 250 WORDS. IT IS CRUCIAL TO ALWAYS CHECK THE SUBMISSION GUIDELINES FOR THE SPECIFIC VENUE.

Q: SHOULD I INCLUDE CITATIONS IN MY CHICAGO-STYLE HUMANITIES ABSTRACT?

A: GENERALLY, CITATIONS ARE NOT INCLUDED IN A CHICAGO-STYLE HUMANITIES ABSTRACT. THE ABSTRACT IS MEANT TO BE A SELF-CONTAINED SUMMARY OF YOUR OWN ORIGINAL RESEARCH, AND EXTERNAL REFERENCES ARE TYPICALLY RESERVED FOR THE FULL PAPER.

Q: HOW DO I EFFECTIVELY CONVEY COMPLEX THEORETICAL CONCEPTS IN A CONCISE ABSTRACT?

A: TO EFFECTIVELY CONVEY COMPLEX THEORETICAL CONCEPTS, FOCUS ON THE APPLICATION AND IMPLICATION OF THE THEORY WITHIN YOUR RESEARCH RATHER THAN DELVING INTO ITS INTRICACIES. BRIEFLY NAME THE THEORY AND STATE HOW IT INFORMS YOUR ANALYSIS OR ARGUMENT. USE PRECISE BUT ACCESSIBLE LANGUAGE.

Q: WHAT IS THE DIFFERENCE BETWEEN AN ABSTRACT AND AN INTRODUCTION IN A HUMANITIES PAPER?

A: AN ABSTRACT IS A BRIEF, STANDALONE SUMMARY OF THE ENTIRE PAPER, TYPICALLY APPEARING AT THE BEGINNING. AN INTRODUCTION, ON THE OTHER HAND, IS PART OF THE MAIN TEXT AND ELABORATES ON THE BACKGROUND, RESEARCH QUESTION, THESIS, AND ROADMAP OF THE PAPER, SERVING AS AN ENTRY POINT INTO THE LARGER ARGUMENT.

Q: CAN I USE FIRST-PERSON PRONOUNS (E.G., "I," "MY") IN MY CHICAGO-STYLE HUMANITIES ABSTRACT?

A: WHILE THE CHICAGO MANUAL OF STYLE ITSELF OFTEN FAVORS THE ACTIVE VOICE WHICH CAN NATURALLY LEAD TO FIRST-PERSON USAGE IN THE FULL TEXT, ABSTRACTS ARE GENERALLY EXPECTED TO BE OBJECTIVE SUMMARIES. MANY STYLE GUIDES AND INSTITUTIONS RECOMMEND AVOIDING FIRST-PERSON PRONOUNS IN ABSTRACTS TO MAINTAIN A MORE FORMAL AND UNIVERSALLY APPLICABLE TONE. HOWEVER, SOME MODERN HUMANITIES ABSTRACT STYLES ARE MORE FLEXIBLE; IT IS BEST TO CONSULT THE SPECIFIC GUIDELINES OF YOUR PUBLISHER OR INSTITUTION.

Q: HOW DO I ENSURE MY HUMANITIES ABSTRACT IS DISCOVERABLE BY SEARCH ENGINES?

A: ENSURE YOUR ABSTRACT INCLUDES RELEVANT KEYWORDS THAT ACCURATELY REFLECT YOUR RESEARCH'S CORE THEMES, METHODOLOGIES, AND SUBJECTS. THINK ABOUT THE TERMS SCHOLARS WOULD USE WHEN SEARCHING FOR INFORMATION IN YOUR SPECIFIC AREA OF THE HUMANITIES.

Q: WHAT IF MY RESEARCH IS INTERDISCIPLINARY? HOW SHOULD I REFLECT THAT IN MY ABSTRACT?

A: IF YOUR RESEARCH IS INTERDISCIPLINARY, AIM TO HIGHLIGHT THE PRIMARY DISCIPLINE OR FOCUS WHILE SUBTLY INDICATING THE INTERDISCIPLINARY CONNECTIONS. USE KEYWORDS THAT SPAN THE RELEVANT FIELDS, AND BRIEFLY MENTION THE METHODOLOGIES OR THEORETICAL FRAMEWORKS BORROWED FROM OTHER DISCIPLINES.

Q: IS IT ACCEPTABLE TO MENTION THE LIMITATIONS OF MY RESEARCH IN THE ABSTRACT?

A: TYPICALLY, ABSTRACTS FOCUS ON THE POSITIVE CONTRIBUTIONS AND FINDINGS OF YOUR RESEARCH. MENTIONING LIMITATIONS IS GENERALLY RESERVED FOR THE DISCUSSION OR CONCLUSION SECTIONS OF THE FULL PAPER. THE ABSTRACT AIMS TO PRESENT THE STRENGTHS AND CORE ARGUMENT OF YOUR WORK.
