NAVIGATING DIGITAL SOURCES AND CITATIONS

MULTIMEDIA AND CHICAGO STYLE

INCORPORATING DATA AND COMPUTATIONAL METHODS

AS COMPUTATIONAL METHODS BECOME MORE PREVALENT IN HUMANITIES RESEARCH, THE NATURE OF THE "SOURCES" BEING CITED EXPANDS. RESEARCHERS MIGHT CITE DATASETS, SOFTWARE USED FOR ANALYSIS, OR ALGORITHMS. CHICAGO STYLE IS EVOLVING TO INCLUDE RECOMMENDATIONS FOR CITING THESE NON-TRADITIONAL RESEARCH OUTPUTS. PREVENTING PLAGIARISM AND ENSURING TRANSPARENCY

THE FUNDAMENTAL PURPOSE OF ANY CITATION STYLE, INCLUDING CHICAGO, IS TO GIVE CREDIT WHERE CREDIT IS DUE AND TO PREVENT PLAGIARISM.
