Understanding the Two Chicago Citation Systems

The Notes and Bibliography System

The notes and bibliography system is characterized by the use of superscript numbers within the text that correspond to either footnotes at the bottom of the page or endnotes collected at the end of the document. Basic Footnote/Endnote Structure

When you introduce information from a source for the first time, you will create a full note. Subsequent citations of the same source will use a shortened version. The full note typically includes the author's name (first name first), the title of the work in italics (or quotation marks for shorter pieces like articles), publication details (city, publisher, year), and the specific page number(s) being referenced.

Shortened Footnote/Endnote Structure

For subsequent citations of the same source, a shortened note is used. This usually includes the author's last name, a shortened title of the work, and the page number. This brevity prevents redundancy while still providing enough information to locate the source in the bibliography.

The Bibliography

The bibliography is an alphabetized list of all sources cited in the text. Its format differs slightly from the notes; for books, the author's last name appears first, followed by the first name. Publication details are also presented in a specific order, and page numbers for specific citations are omitted unless referencing a specific part of a larger work, like a chapter.

The Author-Date System

The author-date system, favored in fields that often engage with empirical research and quantitative data, provides a more concise in-text citation. It directly integrates the author's last name and the year of publication into the sentence or uses parenthetical citations. This system is particularly useful for disciplines where a quick glance at the publication date is important for contextualizing the research.

In-Text Citations with Author-Date

In this system, citations appear within parentheses in the text, typically at the end of a sentence or clause. The format is generally (Author Last Name Year, Page Number). For example, (Smith 2020, 45). If the author's name is mentioned in the sentence, only the year and page number (if applicable) are needed within the parentheses: As Smith (2020) argues, ... (45).

The Reference List

Corresponding to the author-date system is the reference list. This list is alphabetized by the author's last name and includes full publication details for every source cited in the text. The format for entries in the reference list is similar to the bibliography in the notes system but without specific page numbers for the entire work, though chapter or article page ranges are included.

Key Components of Chicago Style In-Text Citations

Regardless of the system chosen, accurate Chicago style in-text citations require attention to several core components. These elements ensure that readers can easily identify the source of the information and find the full bibliographic details. Precision in these details is paramount for academic integrity and scholarly rigor.

Author Information

This is the most critical piece of information. It must accurately reflect the author(s) or editor(s) of the work. Consistency in how author names are presented, whether full name or last name only, is vital depending on the chosen citation system and whether the author is mentioned in the text.

Publication Year

Books

Journal Articles

For a journal article, the citation includes the article title, journal title, volume, issue, year, and page numbers. In the notes system: ¹ Jane Doe, "The Impact of Urban Development," *Journal of Urban Studies* 30, no. 2 (2018): 120. Shortened note: Doe, "Urban Development," 125. In the author-date system: (Doe 2018, 120) and (Doe 2018, 125).

Websites

Citing online sources requires careful consideration of available information. For websites, include the author (if known), title of the specific page or article, website name, publication or last updated date, and the URL. In the notes system: ¹ "Research Methods," Pew Research Center, last modified October 26, 2023, <https://www.pewresearch.org/methods>. Shortened note: "Research Methods." In the author-date system: (Pew Research Center, n.d.) or (Pew Research Center, 2023) if a date is available.
