Understanding Chicago Style Citation Systems

The Author-Date System for Blog Posts

The author-date system, often preferred for its straightforwardness in online content, uses parenthetical citations within the text that include the author's last name and the year of

publication. This method is highly effective for Chicago style in-text citations for blog posts as it offers immediate context without interrupting the flow significantly.

Citing Specific Online Content in Chicago Style

The digital landscape is vast, and blog posts often draw from a variety of online formats. Chicago style provides guidance for citing these diverse sources accurately, ensuring that readers can locate the information you've used. Mastering these specific citations is key to robust Chicago style in-text citations for blog posts.

Citing Blog Posts

When citing another blog post, you'll need to include the author's name, the title of the post, the name of the blog (*italicized*), the publication date, and the URL. The specific format will vary slightly between the notes-bibliography and author-date systems, as demonstrated previously.

For the author-date system, you might include the year in the in-text citation if relevant. In the notes-bibliography system, the full details are in the note.

If you are referencing a specific comment made by a reader on a blog post or article, you should identify the commenter (if known), the content of the comment, the blog post or article it appeared under, the blog or website name, and the date. Due to the difficulty in directly linking to a specific comment, it's often best to provide enough detail so the reader can find it by navigating to the original post.
