Understanding the Two Chicago Style Systems

Citing Multiple Authors

For three or more authors, typically only the first author's last name is listed, followed by "et al." in Author-Date citations. In the Notes-Bibliography system, the full list of authors is generally provided in the initial note and the bibliography entry, with subsequent notes using the first author and "et al." if there are more than two authors.
