Understanding the Fundamentals of Chicago Style Legal Citations for Books

When citing older works, historical context is important, and the publication year helps establish this.

Specific Page Numbers

When citing a specific point within a book, the exact page number(s) must be provided. This allows the reader to pinpoint the precise location of the referenced material. For a range of pages, use an en dash (–) between the first and last page numbers. If citing a specific edition or a particular section, additional identifiers may be necessary.

Footnote Citations for Books in Chicago Style

Footnotes are the primary method of citation within legal documents written in Chicago style (specifically, the Bluebook). They appear at the bottom of the page and provide immediate reference to the source material.

Basic Footnote Format

A typical footnote citation for a book will include the author's name, the italicized title, publication information, and the specific page number(s). The format generally follows this structure:

- First Name Last Name, *Title of Book* (Publication City: Publisher, Year), Page(s).

Subsequent Citations (Id. and Supra)

To avoid redundancy, legal citation practice employs shortcuts for subsequent references to the same source. "Id." is used when the immediately preceding citation refers to the same work and the same pinpoint. If the preceding citation is to the same work but a different pinpoint, "Id. at Page(s)" is used. "Supra" is used for subsequent citations when there are intervening citations to different sources. The "supra" citation will include the author's last name and the pinpoint.

- **First Citation:** Charles Alan Wright & Arthur R. Miller, *Federal Practice and Procedure* (St. Paul, MN: West Publishing Co., 1982), § 7010, at 265.
- **Subsequent, same pinpoint:** Id.
- **Subsequent, different pinpoint:** Id. at 270.
- **Intervening citation, then reference to same book:** Wright & Miller, *supra* note 1, at 275.

Citing Specific Sections or Chapters

Sometimes, you may need to cite a specific section (like a numbered paragraph in a treatise) or a particular chapter rather than just a page. The Bluebook has specific conventions for this, often including the section symbol (§) or chapter number (ch.).

- Charles Alan Wright & Arthur R. Miller, *Federal Practice and Procedure* (St. Paul, MN: West Publishing Co., 1982), § 7010.

Bibliography Entries for Books in Chicago Style

The bibliography, typically found at the end of a legal document, provides a comprehensive list of all sources cited. Unlike footnotes, bibliography entries are alphabetized by author's last name and do not use "Id." or "supra."

Basic Bibliography Format

The bibliography entry for a book is similar to the footnote but omits the specific page numbers unless the entire book is being referenced in a way that emphasizes its entirety. The author's last name typically comes first.

- Last Name, First Name. *Title of Book*. Publication City: Publisher, Year.

Using the previous example:

- Wright, Charles Alan, and Arthur R. Miller. *Federal Practice and Procedure*. St. Paul, MN: West Publishing Co., 1982.

Multiple Authors in Bibliography

For bibliographies, if there are multiple authors, the first author's name is reversed (Last Name, First Name), and subsequent authors are listed in normal order (First Name Last Name). If there are many authors, consult the Bluebook for specific guidelines on how to list them to avoid excessive length.

- Smith, John, and Jane Doe. *The Art of Legal Writing*. New York: Legal Press, 2020.

Editions and Volumes

If you are citing a specific edition or volume of a multi-volume work, this information must be clearly indicated in both footnotes and bibliography entries.

- Author Last Name, First Name. *Title of Book*. Vol. X. Publication City: Publisher, Year.
- Author Last Name, First Name. *Title of Book*. Xth ed. Publication City: Publisher, Year.

Variations and Special Cases in Chicago Style Book Citations

The Bluebook addresses numerous variations and special cases to ensure comprehensive and accurate citation of all types of books, including edited volumes, books with no author, and translations.

Edited Books

When citing a book that has been edited rather than authored by the individual whose work is being referenced (e.g., a collection of essays), the editor(s) should be identified.

- Editor First Name Last Name, ed., *Title of Edited Book* (Publication City: Publisher, Year), Page(s).
- In the bibliography: Last Name, First Name, ed. *Title of Edited Book*. Publication City: Publisher, Year.

Books with No Author

If a book lacks a named author, the citation begins with the title of the book. This is the same for both footnotes and bibliographies.

- *Title of Book* (Publication City: Publisher, Year), Page(s).
- In the bibliography: *Title of Book*. Publication City: Publisher, Year.

Translations and Subsequent Editions

When citing a translated work, it is important to include the translator's name. For subsequent editions, specifying the edition number is crucial for accuracy.

- Author First Name Last Name, *Title of Book*, trans. Translator First Name Last Name (Publication City: Publisher, Year), Page(s).
- Author First Name Last Name, *Title of Book*, Xth ed. (Publication City: Publisher, Year), Page(s).
