Understanding the Two Chicago Style Systems

Author-Date System: In-Text Citations

These citations typically include the author's last name and the year of publication, and sometimes a page number for direct quotations. The goal is to provide just enough information for the reader to locate the full citation in the reference list without disrupting the flow of the text.

Basic Author-Date In-Text Citation

For a general reference to a work, you include the author's last name and the publication year. If the author's name is already mentioned in the sentence, you only need to provide the year in parentheses.

- (Smith 2020)
- According to Smith (2020), the findings were significant.

Including Page Numbers

When quoting directly or paraphrasing a specific idea from a particular page, it is essential to include the page number. This helps readers pinpoint the exact location of the information in the source.

- (Johnson 2019, 45)
- The study highlighted the importance of collaboration (Davis 2021, 112-115).

Citing Multiple Authors

The treatment of multiple authors in the author-date system follows specific guidelines. For two authors, both names are included. For three or more authors, only the first author's last name is used, followed by "et al."

- (Williams and Brown 2018)
- (Garcia et al. 2022)

Citing Works with No Author

If a work lacks an author, you typically use a shortened version of the title (italicized if it's a standalone work like a book, or in quotation marks if it's an article or chapter) in place of the author's name.

- (The Future of AI 2023, 30)
- ("Understanding Climate Change" 2021, 8)

Author-Date System: Reference List Examples

The reference list is an alphabetical compilation of all sources cited in the paper, providing full bibliographic details for each entry. This list allows readers to find and consult the original sources.

Book (Monograph) Example

This format is used for single-author books.

- Author Last Name, First Name. Year. *Title of Book*. City of Publication: Publisher.
- Smith, John. 2020. *Theories of Modern Art*. Chicago: University of Chicago Press.

Journal Article Example

This example shows how to cite a scholarly article from a journal.

- Author Last Name, First Name. Year. "Article Title." *Journal Title* Volume, no. Issue (Month/Season): Page Numbers.

Website Article Example

Citing online content requires careful attention to detail, including URLs and access dates.

- Author Last Name, First Name (if available). Year. "Article Title." Website Name. Last modified Month Day, Year (if available). Accessed Month Day, Year. URL.
- Davis, Robert. 2021. "Sustainable Urban Planning." *Green Living Today*. Last modified March 15, 2021. Accessed October 26, 2023. <https://www.greenlivingtoday.com/sustainable-urban-planning>.

Notes-Bibliography System: Footnotes and Endnotes

The notes-bibliography system uses numbered notes (either footnotes at the bottom of the page or endnotes at the end of the document) to cite sources. Each note corresponds to a superscript number in the text. The first time a source is cited, the note includes full bibliographic information. Subsequent citations of the same source are abbreviated.

First Note Citation Example

This is how a source would be cited the first time it appears in your notes.

- 1. Author Last Name, First Name, *Title of Book* (City of Publication: Publisher, Year), Page Number.
- 1. Smith, John, *Theories of Modern Art* (Chicago: University of Chicago Press, 2020), 55.

Subsequent Note Citation Example

After the first full citation, shorter notes are used for subsequent references to the same work.

- 2. Author Last Name, *Shortened Title*, Page Number.

- 2. Smith, *Modern Art*, 78.

Notes for Journal Articles and Websites

Similar principles apply to citing journal articles and websites in notes, with full details for the first mention and abbreviated details thereafter.

Notes-Bibliography System: Bibliography Examples

The bibliography is an alphabetical list of all sources consulted and cited in the paper, providing full bibliographic details for each entry, similar to the author-date reference list. The key difference lies in the formatting of names and punctuation, which can vary slightly from the reference list in the author-date system.

Book (Monograph) Example

This is the standard format for a book in the bibliography.

Citing Common Source Types

- Web Page without Author: "Page Title." Website Name. Last modified Month Day, Year. Accessed Month Day, Year. URL.
- Organization as Author: Organization Name. "Report Title." Publication Year. URL.

Interviews

Citing interviews, whether published or personal, requires specifying the interviewee, interviewer (if applicable), date, and location/medium.

- Personal Interview: Interviewee Last Name, First Name. Personal interview by Interviewer Last Name, First Name. Month Day, Year.
- Published Interview: Interviewee Last Name, First Name. Interview by Interviewer Last Name, First Name. *Publication Title*, Month Day, Year.

Other Less Common Sources

Chicago style also provides guidance for citing a variety of other materials, ensuring comprehensive coverage.

- Newspaper Article: Author Last Name, First Name. "Article Title." *Newspaper Title*, Month Day, Year.
- Book Chapter: Author Last Name, First Name. "Chapter Title." In *Book Title*, edited by Editor Last Name, First Name, Page Numbers. City: Publisher, Year.
- Film: Film Title. Directed by Director Last Name. Production Company, Year.
