Reference List Formatting (Author-Date System)

The Reference List in the Author-Date system is similar in purpose to the Bibliography but formatted to align with the parenthetical in-text citations. Entries are also alphabetized by author's last name. The key difference is the inclusion of the publication year immediately after the author's name. Book titles and journal titles are italicized, and article titles are enclosed in quotation marks.

- **Book:** Author Last Name, First Name. Year. Book Title. Place of Publication: Publisher.
- **Journal Article:** Author Last Name, First Name. Year. "Article Title." Journal Title Volume (Issue): Page Range.
- **Chapter in an Edited Book:** Author Last Name, First Name. Year. "Chapter Title." In Book Title, edited by Editor First Name Last Name, Page Range. Place of Publication: Publisher.
