The Notes-Bibliography System for Audiovisual Sources

In the bibliography:

Benioff, David, and D. B. Weiss, creators. "The Winds of Winter." *Game of Thrones*, Season 6, Episode 10, HBO, June 26, 2016. Directed by Miguel Sapochnik. Blu-ray.

Citing Podcasts and Radio Programs

Podcasts and radio programs are increasingly common sources, and Chicago style provides clear guidelines for citing them. Key information includes the host(s), episode title, podcast or program name, producer or network, release date, and episode number or season. For audio-only content, the format is often implied as an audio file or stream.

For a footnote or endnote:

1. Host's Name, "Episode Title," *Podcast/Program Name*, Season Number (if applicable), Episode Number (if applicable), Producer/Network, Release Date. Audio file or stream.

For a bibliography entry:

Host's Name. "Episode Title." *Podcast/Program Name*. Season Number (if applicable), Episode Number (if applicable). Producer/Network, Release Date. Audio file or stream.

A podcast citation example:

Sean Ramesburg, "The Rise of the Great Pacific Garbage Patch," *Twenty Thousand Hertz*, Episode 56, December 21, 2021. Podcast audio file.

In the bibliography:

Ramesburg, Sean. "The Rise of the Great Pacific Garbage Patch." *Twenty Thousand Hertz*. Episode 56. December 21, 2021. Podcast audio file.

Citing Music and Sound Recordings

Citing music involves identifying the performer(s), composer(s) or songwriter(s), the title of the song or album, the record label, the release year, and the specific format (e.g., CD, vinyl, streaming). For songs, it's essential to distinguish between the song title and the album title if they differ.

For a footnote or endnote:

1. Performer's Name, "Song Title," on *Album Title*, Record Label, Year. Medium.

For a bibliography entry:

Performer's Name. "Song Title." *Album Title*. Record Label, Year. Medium.

An example of a song citation:

Taylor Swift, "All Too Well (10 Minute Version) (Taylor's Version) (From The Vault)," on *Red (Taylor's Version)*, Republic Records, 2021. Digital stream.

In the bibliography:

Citing Online Audiovisual Content (YouTube, Vimeo, etc.)

Citing content from platforms like YouTube or Vimeo requires a slightly adapted approach, as the creator

might be an individual, a channel, or an organization, and the "publisher" is the platform itself. Include the uploader, the title of the video, the platform name, the publication date, and the URL.

For a footnote or endnote:

1. Uploader's Name or Channel Name, "Video Title," *Platform Name*, Publication Date, URL.

For a bibliography entry:

Uploader's Name or Channel Name. "Video Title." *Platform Name*. Publication Date. URL.

A YouTube video citation example:

National Geographic, "The Arctic Fox vs. The Snowy Owl | Planet Earth II," *YouTube*, December 12, 2020, <https://www.youtube.com/watch?v=example>.

In the bibliography:

National Geographic. "The Arctic Fox vs. The Snowy Owl | Planet Earth II." *YouTube*. December 12, 2020. <https://www.youtube.com/watch?v=example>.

The Author-Date System for Audiovisual Sources

The Author-Date system, more common in the social sciences and sciences, uses in-text citations with author and date, and a reference list at the end of the paper. When adapting this system for audiovisual materials, the "author" is often the primary creator (director, performer, host) or the title if no clear author is identifiable. The date of publication or release is essential for the in-text citation.

For an in-text citation:

When a clear author is present:

(Director's Last Name Year)

When citing a film:

(Curtiz 1942)

When citing a television episode without a clear individual author:

(Series Title Year)

(Game of Thrones 2016)

For a reference list entry, the structure is similar to the Notes-Bibliography system, but the emphasis is on

author and date.
