The Author-Date System

Parenthetical Citations

When an author is mentioned within the text of the sentence, only the year and page number (if applicable) need to be included in the parentheses. The Reference List

At the end of the paper, a "References" list is provided, containing all the sources cited in the parenthetical citations. This list is alphabetized by the author's last name.
