THIS INVOLVES PLACING A SUPERScript NUMBER IN THE TEXT AT THE POINT WHERE A SOURCE IS REFERENCED, WITH A CORRESPONDING NOTE AT THE BOTTOM OF THE PAGE (FOOTNOTE) OR AT THE END OF THE DOCUMENT (ENDNOTE). THESE NOTES PROVIDE DETAILED SOURCE INFORMATION. WHEN IMPLEMENTING THIS ON A WEBSITE, CAREFUL FORMATTING OF THESE NOTES IS ESSENTIAL FOR MAINTAINING CLARITY AND PROFESSIONALISM.

CITING WEB PAGES AND ONLINE ARTICLES

CITING WEB PAGES AND ONLINE ARTICLES IN CHICAGO STYLE REQUIRES SPECIFIC INFORMATION. COMMON PITFALLS IN WEBSITE CHICAGO STYLE PROOFREADING
