Understanding the Chicago Manual of Style

The Chicago Manual of Style (CMOS) is a widely respected style guide that offers two primary systems for citation: the Notes-Bibliography system and the Author-Date system. Journal Articles in the Author-Date System

Citing Magazine Articles
