BEST PRACTICES FOR POLISHING YOUR CHICAGO STYLE ABSTRACT

UNDERSTANDING THE PURPOSE OF A CHICAGO STYLE ABSTRACT

THE PRIMARY PURPOSE OF AN ABSTRACT IS TO PROVIDE A BRIEF, SELF-CONTAINED SUMMARY OF A RESEARCH PAPER. FOR ACADEMIC AND PROFESSIONAL AUDIENCES, IT ACTS AS A CRITICAL TOOL FOR QUICKLY ASSESSING THE RELEVANCE AND SIGNIFICANCE OF THE WORK. IN THE CONTEXT OF CHICAGO STYLE, WHICH EMPHASIZES DETAILED SCHOLARLY INQUIRY, THE ABSTRACT MUST BE PARTICULARLY PRECISE. IT ALLOWS POTENTIAL READERS, INCLUDING JOURNAL EDITORS, CONFERENCE REVIEWERS, AND FELLOW RESEARCHERS, TO DETERMINE IF THE FULL PAPER ALIGNS WITH THEIR INTERESTS AND NEEDS WITHOUT HAVING TO READ THE ENTIRE DOCUMENT. A WELL-WRITTEN ABSTRACT CAN SIGNIFICANTLY INFLUENCE WHETHER YOUR RESEARCH IS READ, CITED, OR EVEN CONSIDERED FOR PUBLICATION.

FURTHERMORE, ABSTRACTS ARE OFTEN INDEXED IN DATABASES AND SEARCH ENGINES, MAKING THEM THE FIRST POINT OF CONTACT FOR INDIVIDUALS SEEKING INFORMATION ON A SPECIFIC TOPIC. THEREFORE, THE CLARITY, ACCURACY, AND CONCISENESS OF YOUR ABSTRACT DIRECTLY IMPACT THE DISCOVERABILITY OF YOUR RESEARCH. IT SHOULD ENCAPSULATE THE ESSENCE OF YOUR STUDY – ITS BACKGROUND, OBJECTIVES, METHODOLOGY, KEY FINDINGS, AND IMPLICATIONS – IN A MANNER THAT IS BOTH INFORMATIVE AND ENGAGING, ADHERING TO THE RIGOROUS STANDARDS EXPECTED IN CHICAGO STYLE SCHOLARLY WORK.

KEY COMPONENTS OF A CHICAGO STYLE RESEARCH PAPER ABSTRACT

A ROBUST CHICAGO STYLE RESEARCH PAPER ABSTRACT TYPICALLY INCLUDES SEVERAL CORE ELEMENTS, EACH SERVING A SPECIFIC FUNCTION IN CONVEYING THE RESEARCH'S ESSENCE. THESE COMPONENTS, WHEN THOUGHTFULLY INTEGRATED, CREATE A COHERENT AND INFORMATIVE SUMMARY THAT ACCURATELY REFLECTS THE FULL PAPER'S CONTENT AND CONTRIBUTIONS. INTRODUCTION AND BACKGROUND

BEGIN BY BRIEFLY SETTING THE CONTEXT FOR YOUR RESEARCH. THIS INVOLVES STATING THE GENERAL AREA OF STUDY AND HIGHLIGHTING THE PROBLEM OR GAP IN EXISTING KNOWLEDGE THAT YOUR RESEARCH ADDRESSES. KEEP THIS PART CONCISE,

USUALLY A SENTENCE OR TWO, TO QUICKLY ORIENT THE READER TO THE SIGNIFICANCE OF YOUR WORK WITHIN ITS FIELD.

RESEARCH OBJECTIVES AND QUESTIONS

CLEARLY ARTICULATE WHAT YOU AIMED TO ACHIEVE WITH YOUR RESEARCH. STATE THE SPECIFIC GOALS, HYPOTHESES, OR RESEARCH QUESTIONS THAT GUIDED YOUR INVESTIGATION. THIS SECTION DEFINES THE SCOPE OF YOUR STUDY AND WHAT SPECIFIC OUTCOMES YOU WERE LOOKING FOR.

METHODOLOGY

DESCRIBE THE APPROACH YOU TOOK TO ANSWER YOUR RESEARCH QUESTIONS OR TEST YOUR HYPOTHESES. THIS INCLUDES MENTIONING THE RESEARCH DESIGN, DATA COLLECTION METHODS, AND ANALYTICAL TECHNIQUES EMPLOYED. BE SPECIFIC ENOUGH TO GIVE THE READER AN UNDERSTANDING OF YOUR RESEARCH PROCESS WITHOUT GOING INTO EXCESSIVE DETAIL.

KEY FINDINGS AND RESULTS

THIS IS ARGUABLY THE MOST CRITICAL PART OF THE ABSTRACT. PRESENT THE MOST SIGNIFICANT OUTCOMES OF YOUR RESEARCH. FOCUS ON THE RESULTS THAT DIRECTLY ADDRESS YOUR OBJECTIVES OR ANSWER YOUR RESEARCH QUESTIONS. USE CLEAR AND PRECISE LANGUAGE, AND IF POSSIBLE, INCLUDE QUANTIFIABLE DATA OR MAJOR TRENDS OBSERVED.

CONCLUSION AND IMPLICATIONS

SUMMARIZE THE MAIN CONCLUSIONS DRAWN FROM YOUR FINDINGS. DISCUSS THE BROADER IMPLICATIONS OF YOUR RESEARCH – WHAT DO YOUR RESULTS MEAN FOR THE FIELD, FOR PRACTICE, OR FOR FUTURE RESEARCH? THIS SECTION HIGHLIGHTS THE CONTRIBUTION AND SIGNIFICANCE OF YOUR WORK.

STRUCTURING YOUR CHICAGO STYLE ABSTRACT EFFECTIVELY

THE EFFECTIVE STRUCTURING OF A CHICAGO STYLE ABSTRACT IS NOT MERELY ABOUT INCLUDING THE RIGHT COMPONENTS; IT'S ABOUT ARRANGING THEM IN A LOGICAL AND COMPELLING SEQUENCE. A WELL-STRUCTURED ABSTRACT GUIDES THE READER SEAMLESSLY FROM THE PROBLEM TO THE SOLUTION AND ITS BROADER IMPACT, ENSURING THAT THE CORE MESSAGE OF YOUR RESEARCH IS IMMEDIATELY APPARENT. THE FLOW SHOULD BE INTUITIVE, MIRRORING THE PROGRESSION OF THE RESEARCH ITSELF.

TYPICALLY, A CHICAGO STYLE ABSTRACT FOLLOWS AN INVERTED PYRAMID STRUCTURE, STARTING WITH THE MOST IMPORTANT INFORMATION AND GRADUALLY PROVIDING MORE CONTEXT. THIS APPROACH ENSURES THAT EVEN IF A READER ONLY SKIMS THE ABSTRACT, THEY GRASP THE ESSENTIAL FINDINGS. THE STANDARD ORDER USUALLY BEGINS WITH THE PROBLEM STATEMENT OR BACKGROUND, MOVES TO THE OBJECTIVES, THEN THE METHODOLOGY, FOLLOWED BY THE KEY RESULTS, AND FINALLY, THE CONCLUSIONS AND IMPLICATIONS. EACH SECTION SHOULD TRANSITION SMOOTHLY TO THE NEXT, CREATING A UNIFIED AND COHERENT NARRATIVE WITHIN THE LIMITED WORD COUNT.

THE FLOW OF INFORMATION

BEGIN WITH A BROAD STATEMENT THAT INTRODUCES THE RESEARCH AREA AND THE PROBLEM ADDRESSED. THIS IMMEDIATELY GROUNDS THE READER. FOLLOWING THIS, CLEARLY STATE YOUR RESEARCH AIMS OR QUESTIONS. THEN, BRIEFLY EXPLAIN YOUR CHOSEN METHODOLOGY. THE BULK OF THE ABSTRACT SHOULD THEN FOCUS ON PRESENTING YOUR MOST IMPACTFUL FINDINGS. CONCLUDE WITH A CONCISE SUMMARY OF YOUR CONCLUSIONS AND THEIR SIGNIFICANCE. THIS STRUCTURED PROGRESSION ENSURES THAT ALL ESSENTIAL INFORMATION IS CONVEYED IN A LOGICAL ORDER.

ADHERING TO WORD LIMITS

A CRITICAL ASPECT OF ABSTRACT WRITING, ESPECIALLY IN ACADEMIC SETTINGS, IS ADHERENCE TO STRICT WORD LIMITS, OFTEN BETWEEN 150 AND 250 WORDS. THIS CONSTRAINT DEMANDS PRECISION AND CAREFUL SELECTION OF EVERY WORD. EVERY SENTENCE MUST CONTRIBUTE MEANINGFULLY TO THE OVERALL SUMMARY. THEREFORE, AFTER DRAFTING YOUR ABSTRACT, METICULOUSLY REVIEW IT TO ELIMINATE ANY REDUNDANT PHRASES OR LESS CRUCIAL DETAILS. PRIORITIZE THE CORE MESSAGE AND FINDINGS TO FIT WITHIN THE SPECIFIED LENGTH WHILE MAINTAINING CLARITY AND COMPREHENSIVENESS.

CRAFTING COMPELLING CHICAGO STYLE ABSTRACT WRITING EXAMPLES

EMPLOYING A MIXED-METHODS APPROACH, THE STUDY SURVEYED 500 PARTICIPANTS AGED 18-25 ACROSS FIVE MAJOR U.S. CITIES, ANALYZING THEIR SOCIAL MEDIA USAGE PATTERNS AND POLITICAL ATTITUDES. QUANTITATIVE ANALYSIS REVEALED A STATISTICALLY SIGNIFICANT CORRELATION BETWEEN ENGAGEMENT WITH ECHO CHAMBERS AND HEIGHTENED POLARIZATION ($p < 0.05$). QUALITATIVE INTERVIEWS FURTHER ILLUMINATED THE MECHANISMS THROUGH WHICH ALGORITHMIC CONTENT CURATION REINFORCES EXISTING BELIEFS. THE FINDINGS SUGGEST THAT WHILE SOCIAL MEDIA OFFERS AVENUES FOR POLITICAL EXPRESSION, ITS CURRENT ARCHITECTURE MAY INADVERTENTLY EXACERBATE SOCIETAL DIVISIONS, NECESSITATING CRITICAL MEDIA LITERACY INTERVENTIONS.

EXAMPLE 2: HUMANITIES RESEARCH ABSTRACT

THIS PAPER EXAMINES THE SYMBOLIC REPRESENTATIONS OF URBAN DECAY IN POST-WAR AMERICAN CINEMA, SPECIFICALLY FOCUSING ON FILM NOIR AND NEO-NOIR GENRES. THE RESEARCH POSITS THAT THESE CINEMATIC NARRATIVES NOT ONLY REFLECT BUT ALSO ACTIVELY SHAPE PUBLIC PERCEPTIONS OF AMERICAN CITIES GRAPPLING WITH ECONOMIC DECLINE AND SOCIAL UNREST. THROUGH CLOSE TEXTUAL ANALYSIS OF KEY FILMS FROM THE 1940s AND 1970s, INCLUDING "THE MALTESE FALCON" AND "CHINATOWN," THIS STUDY IDENTIFIES RECURRING VISUAL MOTIFS, CHARACTER ARCHETYPES, AND NARRATIVE STRUCTURES ASSOCIATED WITH THE CRUMBLING URBAN LANDSCAPE. THE ANALYSIS DEMONSTRATES HOW THESE ELEMENTS CONTRIBUTE TO A CINEMATIC ICONOGRAPHY OF ALIENATION AND MORAL AMBIGUITY. THE PAPER CONCLUDES THAT THESE FILMS SERVED AS CULTURAL BAROMETERS, ARTICULATING ANXIETIES ABOUT MODERNITY AND THE LOSS OF CIVIC ORDER, OFFERING A COMPLEX LENS THROUGH WHICH TO UNDERSTAND THE HISTORICAL ANXIETIES OF THEIR RESPECTIVE ERAS.

EXAMPLE 3: NATURAL SCIENCES RESEARCH ABSTRACT

THIS RESEARCH EXPLORES THE EFFICACY OF A NOVEL PROBIOTIC STRAIN, *LACTOBACILLUS CASEI* X17, IN MITIGATING ANTIBIOTIC-INDUCED GUT DYSBIOSIS IN A MURINE MODEL. THE ESCALATING THREAT OF ANTIMICROBIAL RESISTANCE NECESSITATES STRATEGIES TO PRESERVE GUT MICROBIOME HEALTH DURING ANTIBIOTIC TREATMENT. THIS STUDY AIMED TO QUANTIFY THE PROTECTIVE EFFECTS OF *L. CASEI* X17 SUPPLEMENTATION ON MICROBIAL DIVERSITY AND GUT BARRIER INTEGRITY. C57BL/6 MICE WERE ADMINISTERED A BROAD-SPECTRUM ANTIBIOTIC FOLLOWED BY DAILY ORAL GAVAGE OF EITHER *L. CASEI* X17 OR A PLACEBO FOR TWO WEEKS. FECAL MICROBIOTA ANALYSIS VIA 16S rRNA SEQUENCING REVEALED SIGNIFICANT RESTORATION OF BACTERIAL RICHNESS AND DIVERSITY IN THE PROBIOTIC GROUP COMPARED TO CONTROLS (ALPHA DIVERSITY $p < 0.01$). FURTHERMORE, HISTOLOGICAL EXAMINATION OF COLON TISSUE DEMONSTRATED ENHANCED EPITHELIAL BARRIER FUNCTION. THESE RESULTS INDICATE THAT *L. CASEI* X17 HOLDS PROMISE AS A THERAPEUTIC AGENT FOR PREVENTING AND MANAGING ANTIBIOTIC-ASSOCIATED GUT MICROBIOME DISRUPTION.

COMMON PITFALLS TO AVOID IN CHICAGO STYLE ABSTRACT WRITING

EVEN WITH A CLEAR UNDERSTANDING OF THE REQUIRED COMPONENTS, WRITERS CAN SOMETIMES FALL INTO COMMON TRAPS WHEN CRAFTING ABSTRACTS. RECOGNIZING AND ACTIVELY AVOIDING THESE PITFALLS IS CRUCIAL FOR PRODUCING A HIGH-QUALITY, EFFECTIVE SUMMARY THAT ADHERES TO CHICAGO STYLE SCHOLARLY EXPECTATIONS AND EFFECTIVELY REPRESENTS YOUR RESEARCH.

INCLUDING EXCESSIVE DETAIL

ONE OF THE MOST FREQUENT MISTAKES IS INCLUDING TOO MUCH DETAIL ABOUT METHODOLOGY OR SPECIFIC RESULTS THAT ARE NOT ESSENTIAL FOR A GENERAL UNDERSTANDING OF THE RESEARCH. REMEMBER, THE ABSTRACT IS A SUMMARY, NOT A CONDENSED VERSION OF THE ENTIRE PAPER. AVOID JARGON WHERE POSSIBLE OR BRIEFLY DEFINE IT IF IT IS INDISPENSABLE.

VAGUENESS AND LACK OF SPECIFICITY

CONVERSELY, BEING TOO VAGUE CAN RENDER AN ABSTRACT UNHELPFUL. FOR INSTANCE, STATING "WE CONDUCTED AN EXPERIMENT" WITHOUT INDICATING THE NATURE OF THE EXPERIMENT OR WHAT WAS MEASURED IS INSUFFICIENT. BE SPECIFIC ABOUT YOUR RESEARCH QUESTIONS, METHODS, AND FINDINGS TO PROVIDE A CLEAR PICTURE.

OMITTING KEY INFORMATION

FAILURE TO INCLUDE ALL ESSENTIAL COMPONENTS—BACKGROUND, OBJECTIVES, METHODS, FINDINGS, AND CONCLUSIONS—LEAVES THE READER WITH AN INCOMPLETE UNDERSTANDING OF THE RESEARCH. ENSURE THAT EACH CRITICAL ELEMENT IS PRESENT, EVEN IF BRIEFLY MENTIONED.

EXCEEDING WORD COUNT

AS MENTIONED EARLIER, ADHERING TO WORD LIMITS IS VITAL. GOING OVER THE ALLOTTED WORD COUNT CAN LEAD TO REJECTION BY JOURNALS OR A NEGATIVE IMPRESSION ON REVIEWERS. RUTHLESSLY EDIT FOR CONCISENESS.

USING CITATIONS OR REFERENCES

ABSTRACTS IN CHICAGO STYLE, AND MOST OTHER STYLES, SHOULD NOT CONTAIN IN-TEXT CITATIONS OR A REFERENCE LIST. THE ABSTRACT SHOULD BE A SELF-CONTAINED SUMMARY OF YOUR ORIGINAL WORK, NOT A REVIEW THAT RELIES ON EXTERNAL SOURCES FOR ITS CLAIMS.

MAKING UNSUBSTANTIATED CLAIMS

ALL STATEMENTS MADE IN THE ABSTRACT SHOULD BE DIRECTLY SUPPORTED BY THE RESEARCH PRESENTED IN THE FULL PAPER. AVOID HYPERBOLE OR CLAIMS THAT ARE NOT DEMONSTRABLY EVIDENT FROM YOUR FINDINGS. THE ABSTRACT MUST ACCURATELY REFLECT THE SCOPE AND CERTAINTY OF YOUR CONCLUSIONS.

BEST PRACTICES FOR POLISHING YOUR CHICAGO STYLE ABSTRACT

ONCE A DRAFT OF YOUR ABSTRACT IS COMPLETE, DEDICATING TIME TO REFINEMENT IS ESSENTIAL. POLISHING ENSURES THAT YOUR ABSTRACT IS NOT ONLY ACCURATE AND COMPREHENSIVE BUT ALSO AS CLEAR, CONCISE, AND IMPACTFUL AS POSSIBLE,

TRULY REPRESENTING THE RIGOR OF YOUR CHICAGO STYLE RESEARCH PAPER. THIS FINAL STAGE INVOLVES METICULOUS REVIEW AND EDITING.

READABILITY AND CLARITY

ENSURE YOUR LANGUAGE IS CLEAR, DIRECT, AND ACCESSIBLE TO A BROAD ACADEMIC AUDIENCE WITHIN YOUR FIELD. AVOID OVERLY COMPLEX SENTENCE STRUCTURES OR CONVOLUTED PHRASING. EVERY SENTENCE SHOULD SERVE A PURPOSE AND CONTRIBUTE TO THE OVERALL UNDERSTANDING OF YOUR RESEARCH. READING YOUR ABSTRACT ALOUD CAN HELP IDENTIFY AWKWARD PHRASING OR SENTENCES THAT ARE DIFFICULT TO FOLLOW.

REVIEW FOR ACCURACY

DOUBLE-CHECK THAT THE ABSTRACT ACCURATELY REFLECTS THE CONTENT OF YOUR MAIN PAPER. ARE THE OBJECTIVES, METHODS, FINDINGS, AND CONCLUSIONS PRESENTED IN THE ABSTRACT PRECISELY ALIGNED WITH WHAT IS DISCUSSED IN THE BODY OF YOUR RESEARCH? ANY DISCREPANCIES CAN UNDERMINE THE CREDIBILITY OF YOUR WORK.

SEEK FEEDBACK

IF POSSIBLE, HAVE COLLEAGUES, MENTORS, OR PEERS REVIEW YOUR ABSTRACT. AN EXTERNAL PERSPECTIVE CAN HIGHLIGHT AREAS THAT MIGHT BE UNCLEAR OR COULD BE IMPROVED. THEY CAN OFFER VALUABLE INSIGHTS INTO HOW EFFECTIVELY YOUR ABSTRACT COMMUNICATES THE ESSENCE OF YOUR RESEARCH TO SOMEONE UNFAMILIAR WITH IT.

PROOFREAD METICULOUSLY

TYPES, GRAMMATICAL ERRORS, AND PUNCTUATION MISTAKES CAN DETRACT FROM THE PROFESSIONALISM OF YOUR ABSTRACT AND, BY EXTENSION, YOUR RESEARCH. PROOFREAD CAREFULLY, PAYING ATTENTION TO DETAIL, AND CONSIDER USING GRAMMAR-CHECKING SOFTWARE, BUT ALWAYS RELY ON YOUR OWN CRITICAL JUDGMENT FOR THE FINAL REVIEW.

ENSURE KEYWORD INCLUSION

WHILE MAINTAINING NATURAL FLOW, ENSURE THAT RELEVANT KEYWORDS, INCLUDING VARIATIONS OF YOUR MAIN TOPIC LIKE "CHICAGO STYLE RESEARCH PAPER ABSTRACT WRITING EXAMPLES," ARE PRESENT. THIS HELPS IN SEARCH ENGINE OPTIMIZATION AND ALLOWS RESEARCHERS TO FIND YOUR WORK MORE EASILY WHEN SEARCHING ACADEMIC DATABASES.

FREQUENTLY ASKED QUESTIONS (FAQ)

Q: WHAT IS THE TYPICAL WORD COUNT FOR A CHICAGO STYLE RESEARCH PAPER ABSTRACT?

IT'S ALWAYS BEST TO CHECK THE SPECIFIC SUBMISSION REQUIREMENTS OF THE VENUE WHERE YOU INTEND TO PUBLISH OR PRESENT YOUR WORK.

Q: SHOULD I INCLUDE KEYWORDS IN MY CHICAGO STYLE ABSTRACT?

A: WHILE NOT EXPLICITLY PART OF THE ABSTRACT'S MAIN TEXT STRUCTURE, IT IS HIGHLY RECOMMENDED TO INCLUDE A LIST OF KEYWORDS IMMEDIATELY FOLLOWING YOUR ABSTRACT, TYPICALLY ON A SEPARATE LINE. THESE KEYWORDS ARE CRUCIAL FOR

Q: CAN I USE ABBREVIATIONS OR ACRONYMS IN MY CHICAGO STYLE ABSTRACT?

A: ABBREVIATIONS AND ACRONYMS CAN BE USED IF THEY ARE STANDARD AND WIDELY UNDERSTOOD WITHIN YOUR FIELD. HOWEVER, IT IS BEST PRACTICE TO DEFINE THEM UPON THEIR FIRST USE IN THE ABSTRACT, UNLESS THEY ARE EXCEPTIONALLY COMMON. FOR EXAMPLE, "NATIONAL AERONAUTICS AND SPACE ADMINISTRATION (NASA)."

Q: HOW DO I ENSURE MY CHICAGO STYLE ABSTRACT IS OBJECTIVE AND UNBIASED?

A: TO MAINTAIN OBJECTIVITY, FOCUS ON PRESENTING FACTUAL INFORMATION ABOUT YOUR RESEARCH. DESCRIBE YOUR METHODS AND FINDINGS WITHOUT PERSONAL OPINIONS, INTERPRETATIONS, OR OVERLY ENTHUSIASTIC LANGUAGE. THE ABSTRACT SHOULD REPORT ON YOUR RESEARCH, NOT ADVOCATE FOR IT.

Q: WHAT IS THE DIFFERENCE BETWEEN AN ABSTRACT FOR A THESIS AND AN ABSTRACT FOR A JOURNAL ARTICLE IN CHICAGO STYLE?

A: WHILE THE CORE COMPONENTS REMAIN SIMILAR, ABSTRACTS FOR THESES OR DISSERTATIONS MIGHT BE SLIGHTLY LONGER AND MORE DETAILED, AS THEY ARE OFTEN INTENDED TO PROVIDE A COMPREHENSIVE OVERVIEW FOR A BROADER ACADEMIC AUDIENCE AND COMMITTEE. ABSTRACTS FOR JOURNAL ARTICLES ARE TYPICALLY MORE CONCISE AND FOCUSED, ADHERING STRICTLY TO JOURNAL-SPECIFIED WORD LIMITS AND AUDIENCE.

Q: HOW CRUCIAL IS THE "SO WHAT?" ASPECT OF A CHICAGO STYLE ABSTRACT?

A: THE "SO WHAT?" ASPECT, OFTEN CONVEYED IN THE CONCLUSION AND IMPLICATIONS SECTION, IS CRITICALLY IMPORTANT. IT ANSWERS THE QUESTION OF WHY YOUR RESEARCH MATTERS, HIGHLIGHTING ITS CONTRIBUTION TO THE FIELD, ITS PRACTICAL APPLICATIONS, OR ITS POTENTIAL FOR FUTURE STUDY. THIS IS WHAT MAKES YOUR RESEARCH IMPACTFUL AND MEMORABLE.

Q: SHOULD MY CHICAGO STYLE ABSTRACT MENTION FUTURE RESEARCH DIRECTIONS?

A: BRIEFLY MENTIONING FUTURE RESEARCH DIRECTIONS CAN BE APPROPRIATE IF IT NATURALLY FLOWS FROM YOUR FINDINGS AND IMPLICATIONS. HOWEVER, THE PRIMARY FOCUS SHOULD REMAIN ON SUMMARIZING THE COMPLETED RESEARCH. AVOID MAKING THIS SECTION TOO EXTENSIVE, AS IT CAN DETRACT FROM THE CORE FINDINGS.

Q: WHAT IF MY RESEARCH IS THEORETICAL OR QUALITATIVE IN NATURE? HOW DO I SUMMARIZE FINDINGS?

A: FOR THEORETICAL OR QUALITATIVE RESEARCH, YOUR "FINDINGS" MIGHT BE CONCEPTUAL FRAMEWORKS, INTERPRETATIONS, OR THEMATIC ANALYSES. INSTEAD OF QUANTITATIVE DATA, YOU WOULD SUMMARIZE THE KEY INSIGHTS, INTERPRETATIONS, OR THE DEVELOPMENT OF THEORETICAL MODELS THAT EMERGED FROM YOUR ANALYSIS. THE FOCUS IS ON THE INTELLECTUAL CONTRIBUTIONS AND THE UNDERSTANDING GAINED.
