SHIFTING INTO INTERPRETATIVE OR ARGUMENTATIVE TERRITORY TOO EARLY IS A FREQUENT MISTAKE. THE RESULTS SECTION IS FOR REPORTING FACTS; THE 'WHY' AND 'SO WHAT' ARE RESERVED FOR THE DISCUSSION.

VAGUENESS OR LACK OF SPECIFICITY

A CONCLUSION THAT IS TOO VAGUE FAILS TO ADEQUATELY SUMMARIZE THE FINDINGS. WHILE CONCISENESS IS KEY, IT SHOULD NOT COME AT THE EXPENSE OF IMPORTANT DETAIL REGARDING THE OUTCOMES.

REPETITIVE PHRASING

SIMPLY REPEATING SENTENCES OR PHRASES FROM THE MAIN BODY OF THE RESULTS SECTION WITHOUT SYNTHESIZING THEM INTO A COHERENT SUMMARY CAN MAKE THE CONCLUSION FEEL REDUNDANT RATHER THAN CONCLUSIVE.

INTEGRATING RESULTS WITH DISCUSSION

THE CONCLUSION OF THE RESULTS SECTION ACTS AS A SEAMLESS TRANSITION TO THE DISCUSSION. IT PROVIDES A FIRM FOUNDATION OF REPORTED FINDINGS UPON WHICH THE SUBSEQUENT ANALYSIS AND INTERPRETATION CAN BE BUILT. WHILE DISTINCT, THESE SECTIONS ARE INTRINSICALLY LINKED.

ENSURING CLARITY AND CONCISENESS

CLARITY IS ACHIEVED THROUGH DIRECT LANGUAGE AND A LOGICAL FLOW. EACH SENTENCE SHOULD CONTRIBUTE MEANINGFULLY TO THE OVERALL SUMMARY. READING YOUR CONCLUSION ALOUD CAN OFTEN HELP IDENTIFY AWKWARD PHRASING OR AREAS THAT ARE DIFFICULT TO UNDERSTAND. THE GOAL IS TO LEAVE THE READER WITH A CLEAR AND CONFIDENT UNDERSTANDING OF YOUR STUDY'S CORE DISCOVERIES.

FAQ SECTION
