Understanding the Chicago Style Notes-Bibliography System

When referencing an article that was published online and accessed through a database or DOI, include the DOI or URL:

Giddens, Anthony. "The Third Way: The Renewal of Social Democracy." *Political Quarterly* 69, no. 2 (April-June 1998): 129-42. doi:10.1111/1467-923X.00014.

Websites and Online Resources

The internet has become an indispensable source for social science research. Citing online resources requires attention to accessibility and specific publication details.

Last Name, First Name (if available). "Title of Specific Page or Document." *Name of Website*. Last modified or accessed Date. URL.

An example:

Smith, John. "Understanding Qualitative Research Methods." *Sociology Central*. Accessed January 15, 2024. <https://www.sociologycentral.com/qualitativemethods>.

If no author is listed, begin with the title of the page:

"Global Trends in Political Participation." *Pew Research Center*. Last modified March 10,

2023. <https://www.pewresearch.org/globalparticipation>.

Additional Social Science Source Types

Beyond books and journal articles, social scientists frequently utilize a diverse range of source materials. Properly citing these can be complex, but adherence to CMOS guidelines ensures completeness.

Dissertations and Theses

These academic works represent significant original research. The format for a dissertation or thesis in a Chicago style bibliography is:

Last Name, First Name. "Title of Dissertation." Type of work (e.g., PhD dissertation, Master's thesis), University, Year.

Example:

Johnson, Emily R. "The Impact of Social Media on Adolescent Identity Formation." PhD dissertation, University of California, Berkeley, 2020.

Book Chapters

When citing a specific chapter within an edited volume, you need to cite both the chapter author and the editors of the book.

Last Name, First Name. "Title of Chapter." In *Title of Book*, edited by Editor's First Name Last Name and Editor's First Name Last Name, Page numbers. Place of Publication: Publisher, Year of Publication.

For instance:

Foucault, Michel. "Of Other Spaces: Utopias and Heterotopias." In *Rethinking Architecture: A Reader in Cultural Theory*, edited by Neil Leach, 229-34. London: Routledge, 1997.

Interviews

Personal interviews, whether conducted by the author or a third party, are valuable sources.

Last Name, First Name (if conducted by author). Type of interview (e.g., personal interview, email interview). Date of interview.

Example of a conducted interview:

Miller, Sarah. Personal interview. October 26, 2023.

If referencing an interview published or archived elsewhere:

Davis, Marcus. "The Future of Urban Planning." Interview by Anna Lee. *Urban Studies Journal*, November 15, 2022.

Government Documents

Government publications are rich sources for social science data and policy analysis. The citation format can vary, but a common approach is:

Issuing Agency. *Title of Document*. Publication details (report number, series, etc.). Place of Publication: Publisher, Year.

Example:

United States. Department of Justice. Bureau of Justice Statistics. *National Crime Victimization Survey: 2022 Report to the Nation*. Washington, DC: Government Publishing Office, 2023.
