UNDERSTANDING CHICAGO STYLE THESIS REQUIREMENTS

CHICAGO STYLE THESIS REQUIREMENTS

ARE MULTIFACETED AND DEMAND A DEEP UNDERSTANDING OF ACADEMIC WRITING CONVENTIONS. THE CHICAGO MANUAL OF STYLE (CMOS) IS THE AUTHORITATIVE GUIDE, AND ITS APPLICATION TO THESES AND DISSERTATIONS OFTEN INVOLVES SPECIFIC INSTITUTIONAL GUIDELINES LAYERED ON TOP OF THE CORE CMOS PRINCIPLES. THIS STYLE IS PRIMARILY KNOWN FOR ITS TWO MAJOR CITATION SYSTEMS: NOTES-BIBLIOGRAPHY (NB) AND AUTHOR-DATE (AD). THE NB SYSTEM IS PREVALENT IN THE HUMANITIES, WHILE THE AD SYSTEM IS MORE COMMON IN THE SCIENCES AND SOCIAL SCIENCES. BOTH SYSTEMS REQUIRE PRECISE FORMATTING FOR IN-TEXT CITATIONS, FOOTNOTES OR ENDNOTES, AND COMPREHENSIVE BIBLIOGRAPHIES OR REFERENCE LISTS.

THE NOTES-BIBLIOGRAPHY SYSTEM

THE NOTES-BIBLIOGRAPHY SYSTEM, OFTEN REFERRED TO AS THE HUMANITIES STYLE, UTILIZES FOOTNOTES OR ENDNOTES TO CITE SOURCES WITHIN THE TEXT. THESE NOTES PROVIDE DETAILED CITATION INFORMATION, INCLUDING AUTHOR, TITLE, PUBLICATION DETAILS, AND PAGE NUMBERS. THE AUTHOR-DATE SYSTEM

CONVERSELY, THE AUTHOR-DATE SYSTEM, FAVORED IN MANY SCIENTIFIC AND SOCIAL SCIENCE DISCIPLINES, EMPLOYS BRIEF PARENTHETICAL CITATIONS WITHIN THE TEXT. THESE CITATIONS TYPICALLY INCLUDE THE AUTHOR'S LAST NAME AND THE PUBLICATION YEAR, OFTEN WITH A PAGE NUMBER FOR DIRECT QUOTATIONS. A REFERENCE LIST, WHICH IS ESSENTIALLY AN ALPHABETICAL LIST OF ALL CITED SOURCES, IS APPENDED TO THE PAPER. THIS SYSTEM AIMS FOR CONCISENESS WITHIN THE TEXT

WHILE STILL PROVIDING COMPLETE SOURCE IDENTIFICATION IN THE REFERENCE LIST.

INSTITUTIONAL AND PROGRAM-SPECIFIC GUIDELINES

A: YES, MOST MODERN CHICAGO STYLE THESIS FORMATTING SOFTWARE OFFERS PLUGINS OR ADD-INS THAT INTEGRATE
