- **In-text:** (Author Year) or Author (Year). For direct quotes: (Author Year, p.).
- **Reference List:** Entries include author, year, title, and publication information. The exact order and punctuation may differ slightly from APA, especially regarding the placement of the year.

The Harvard Referencing Style

The Harvard style, sometimes referred to as the "name-date" system, is a widely used and flexible author-date system. It is prevalent in many disciplines across the humanities, social sciences, and sciences.
