The American Psychological Association (APA) Style

The American Psychological Association (APA) style is widely used in the social sciences, including psychology, sociology, education, and business. It places a strong emphasis on the author and the date of publication, reflecting the importance of recency in scientific research.

APA Style: In-Text Citations

APA in-text citations include the author's last name and the year of publication. For example: (Jones, 2020). When quoting directly, the page number is also included: (Jones, 2020, p. 115). If the author's name is part of the narrative, the year follows the name: Jones (2020) found that... . For sources without an author, use the title or a shortened version. For sources without a date, use "n.d.".

APA Style: References Page

The APA References page lists all sources cited in the essay, alphabetized by the author's last name. The format for a book typically includes the author's last name and initial(s), the year of publication in parentheses, the title of the book (italicized), and the location of the publisher. Journal articles require specific formatting, including the journal title in italics, volume and issue numbers, and page range. Digital object identifiers (DOIs) are crucial for online sources.

The Chicago Manual of Style

The Chicago Manual of Style (CMOS) is a comprehensive style guide that offers two distinct systems for citation: the Notes and Bibliography system and the Author-Date system. It is frequently used in history, art history, and some social sciences.

Chicago Style: Notes and Bibliography System

In the Notes and Bibliography system, superscript numbers are placed in the text at the end of a quotation or paraphrased idea. These numbers correspond to footnotes or endnotes, which contain the full citation information. The bibliography at the end of the paper provides a complete alphabetical list of all sources consulted, whether cited or not. This system is common in fields that rely heavily on archival research and extensive commentary.

Chicago Style: Author-Date System

The Author-Date system is more akin to APA style. In-text citations consist of the author's last name, the year of publication, and the page number. For example: (Miller 2018, 75). This system is typically used in the sciences and some social sciences. The Council of Science Editors (CSE) Style

CSE Style: Citation-Sequence

In the citation-sequence system, sources are numbered consecutively in the order they appear in the text. The in-text citation is simply the number of the source: (1). CSE Style: Name-Year

The name-year system, similar to APA and Chicago's Author-Date system, uses the author's last name and year of publication for in-text citations: (Davis 2021). If there are multiple works by the same author in the same year, suffixes (a, b, c) are used. The reference list is alphabetized by author's last name and includes full bibliographic details.
