Understanding the Core Components of an MLA Website

Citation

When you cite a website in MLA format, the primary goal is to provide enough information for your reader to find the exact source you used. This involves a specific order of elements designed for clarity and universality. The MLA 9th edition emphasizes accessibility and ease of retrieval, especially as digital sources can change or disappear over time. Mastering these components is the first step towards accurate MLA website citation.

The Essential Elements for Your Works Cited Entry

Every MLA website citation in your Works Cited page is constructed from a set of core elements, although not all may be available for every source. The order and presence of these elements are critical for a correctly formatted entry. These components work together to paint a complete picture of the source, allowing readers to follow your research trail.

Author

The author's name is the starting point for many MLA citations. For websites, this can be an individual author, a corporate author (like an organization or institution), or sometimes no author is listed. If an individual author is named, you will cite them last name first, followed by a comma, then their first name. For example, "Smith, John." If the author is a corporate body, you list the full name of the organization. When no author is identified, you move directly to the next element in the citation.

Title of Source

This element refers to the specific page or article title you are citing. It should be enclosed in quotation marks. For instance, if you are citing an article titled "The Future of Renewable Energy," your citation

would include "The Future of Renewable Energy." This distinguishes the specific piece of content from the larger website it resides on. Consistency in titling is key; ensure you are capturing the exact title as it appears on the webpage.

Title of Container

The "container" is the larger work that the source belongs to. For websites, this is typically the name of the website itself. It is italicized. For example, if the article is on the website National Geographic, then National Geographic would be the title of the container. If the source is part of a larger publication hosted online, like a journal article or a book chapter, the title of that publication would be the container.

Other Contributors

This element can include editors, translators, or other individuals or entities who contributed to the creation of the source, beyond the author. For most website citations, this element might not be applicable, but it is important to consider if there are named editors or contributors listed on the page.

Version

If the website content has a specific version or edition, such as a software program or a specific release of a digital resource, you would include that here. For most standard articles or webpages, this element is not relevant.

Number

This element is typically used for numbered items, like volumes, issues of a journal, or specific editions of a series. It's rarely applicable for general website content but might be used if you are citing a specific installment of a serialized online publication.

Publisher

The publisher is the entity responsible for making the website or its content available. This could be the organization that created the website or a host organization. For instance, if you are citing a government report found on a government agency's website, the agency itself is often considered the publisher. If the author and publisher are the same, you omit the publisher.

Publication Date

The date of publication is a crucial piece of information, especially for online sources that can be updated frequently. MLA uses the day, month, and year format. For example, 15 Oct. 2023. If only a year is available, you would cite just the year. If no date is provided, you move to the next element.

Location

The location provides a way to find the source. For websites, this can be a URL (Uniform Resource Locator) or a DOI (Digital Object Identifier). DOIs are preferred when available as they are permanent links. If a DOI is not available, you provide the URL. MLA 9th edition recommends omitting "http://" or "https://://" from the URL, starting directly with "www." or the domain name. However, including the full URL is still acceptable if it aids clarity.

In-Text Citations for Websites: Parenthetical and Narrative

In-text citations are brief references within the body of your paper that direct readers to the full citation in your Works Cited list. MLA style offers two primary methods: parenthetical and narrative citations. Both are effective for guiding your reader, and the choice often depends on how you are integrating the source material into your prose.

Parenthetical Citations

A parenthetical citation typically includes the author's last name and the page number where the information can be found. However, for most websites, page numbers are not available. In such cases, you will use only the author's last name. For example: (Smith). If the source has no individual author, you use a shortened version of the title of the source (the article or webpage title) in quotation marks. For instance: ("Future of Renewable Energy"). If the author is a corporate body, you use the name of the organization. For example: (National Geographic).

Narrative Citations

A narrative citation integrates the author's name directly into your sentence. This often makes your writing flow more smoothly. For example, you might write: "Smith argues that the future of renewable energy is bright (Future of Renewable Energy)." If you mention the author's name in the sentence, you do not need to repeat it in the parenthetical citation. If the author's name is not mentioned in the sentence, you would use a parenthetical citation as described above. When citing a corporate author, you can use the organization's name in the sentence: "According to National Geographic, advancements in solar technology are accelerating."

Citing Specific Types of Online Content

Citing a Web Page or Article

Blog posts are treated similarly to web pages. The author is usually an individual's name or a username. The "Title of Source" is the title of the blog post. The "Title of Container" is the name of the blog, italicized. If the blog is hosted on a larger platform (like WordPress or a news site), that platform might be considered the publisher or part of the container information.

Citing a Social Media Post

Citing social media requires a slightly different approach. Include the author's username (preceded by "@" if applicable), the content of the post (in quotation marks, often a truncated version if it's long), the name of the platform (italicized) as the container, the publisher (usually the platform itself), the date of posting, and the URL.

Citing a Video or Audio Recording

For online videos (e.g., YouTube, Vimeo) or audio recordings (e.g., podcasts), include the creator as the author, the title of the specific video/episode (in quotation marks), the name of the platform or series (italicized) as the container, the publisher, the date, and the URL. You may also want to specify the medium (e.g., "video" or "audio").

Common Challenges and Solutions in MLA Website Citation

No Author Listed

If a webpage or article has no discernible author, begin your citation with the "Title of Source" in quotation marks. For example: "The Impact of AI on Modern Society." Then proceed with the rest of the citation elements as usual.

No Publication Date Listed

When a publication date is not available, you can use "n.d." (for "no date") in place of the publication date. For example: (Smith, n.d.). However, it is always best to search thoroughly for a date, as it is a valuable piece of information for readers assessing the timeliness of your sources.

Website Name and Publisher are the Same

If the name of the website is identical to the name of the publisher, you omit the publisher information to avoid redundancy. For example, if citing an article from the New York Times website, and The New York Times is listed as both the website name and the publisher, you would not repeat it.

Citing a Source from a Database

When you access a website through a subscription database (like JSTOR, Project MUSE, or EBSCOhost), the citation should reflect this. You will still include the author, title of the article, and title of the journal (if applicable). The "container" would be the database name (*italicized*), followed by the database's publisher (if different from the database name), and the DOI or URL provided by the database. If no DOI is given, you can provide the database name and the page numbers or accession number, if available.

The Role of DOI and URLs in MLA Citations

The "location" element in an MLA website citation is crucial for directing your reader to the source. While URLs have traditionally been used, the emergence of Digital Object Identifiers (DOIs) has provided a more stable and reliable method of locating online content.

Understanding DOIs

A DOI is a unique alphanumeric string assigned to an electronic document. It acts as a permanent link to the resource, meaning it will not change even if the URL of the page is updated or the website is reorganized. However, if omitting the protocol makes the URL unidentifiable or difficult to access, including it is acceptable. Always aim to provide the most direct and stable link possible.
