If a DOI or stable URL is available, it is generally preferred over a standard URL, as these are more permanent.

The final piece of information required is the date you accessed the website. This is crucial because web content can change or be removed without notice. You will format this as Day Month Year (e.g., 15 Oct. 2023).

Citing Specific Types of Website Content

While the core principles of MLA website citation remain consistent, different types of online content may require slight adjustments to your citation format. Understanding these nuances ensures accuracy and completeness in your academic work, demonstrating your attention to detail.

Citing Online News Articles and Blog Posts

If the author is an organization, begin with the organization's name. If no date is available, you can use "n.d." for "no date."

Citing Government Websites and Reports

Government websites often have clear organizational authors. When citing a document from a government website, the name of the government agency or department typically serves as the author. The title of the specific report or document follows, then the website's name (if distinct from the agency), the publisher (often the agency itself), the publication date, and the URL. For instance:

Citing Social Media and Other Informal Online Content

MLA guidelines suggest including the author (username or real name if known), the specific content (briefly described or quoted, in quotation marks), the platform name (italicized), the publication date, and the URL.
