Understanding the Core Components of an MLA Book Citation

Citing a Book with One Author

The basic format for a book with one author is:

Last Name, First Name. *Title of Book*. Publisher, Year of Publication.

For example:

Smith, John. *The Art of Research*. Academic Press, 2022.

Remember to italicize the title of the book. The publisher's name and the year of publication follow, separated by a comma.

Citing a Book with Two or Three Authors

When a book has multiple authors, the MLA format requires you to list all of them. The convention for the first author is Last Name, First Name, but subsequent authors are listed in First Name Last Name order. This distinction helps to clearly identify the primary author while still acknowledging the contributions of co-authors.

For a book with two authors, the format is:

Last Name, First Name, and First Name Last Name. *Title of Book*. Publisher, Year of Publication.

For a book with three authors, the format remains similar:

Last Name, First Name, First Name Last Name, and First Name Last Name. *Title of Book*. Publisher, Year of Publication.

An example for two authors:

Doe, Jane, and Richard Roe. *Collaborative Efforts*. University Publishing, 2021.

Citing a Book with More Than Three Authors

For works with more than three authors, the MLA style simplifies the citation by listing only the first author, followed by the abbreviation "et al." This abbreviation, meaning "and others," is a standard scholarly convention that prevents excessively long Works Cited entries while still crediting the primary author.

The format for citing a book with more than three authors is:

Last Name, First Name, et al. *Title of Book*. Publisher, Year of Publication.

For example:

Miller, Sarah, et al. *Multidisciplinary Approaches*. Global Books, 2020.

This streamlined approach is crucial for maintaining readability in your bibliography, especially when dealing with extensively collaborative works.

Citing an Edited Book

When citing a book that has been compiled and edited by one or more individuals, the editor's contribution is acknowledged in the citation. The editor's name is listed, followed by "ed." for a single editor or "eds." for multiple editors. This designation clearly indicates that the individuals are responsible for curating the content rather than authoring it.

The format for a book with one editor is:

Last Name, First Name, ed. *Title of Book*. Publisher, Year of Publication.

For a book with multiple editors:

Last Name, First Name, and First Name Last Name, eds. *Title of Book*. Publisher, Year of Publication.

An example of a book with one editor:

Williams, Emily, ed. *Essays on Modern Literature*. Literary Society Press, 2019.

Citing a Book with an Editor and Author

In cases where a book has both an author and an editor, such as in a collection of an author's letters or previously unpublished works, both roles are noted. The author's name is typically listed first, followed by the editor's name and designation. This clarifies the relationship between the original creator and the individual who compiled and presented the work.

The format is:

Last Name, First Name (Author). *Title of Book*. Edited by First Name Last Name, Publisher, Year of Publication.

For example:

Austen, Jane. *Letters to Cassandra*. Edited by Penelope Davies, Romantic Era Publications, 2018.

This distinction is important for understanding the genesis and presentation of the literary material.

Citing a Work in an Anthology or Collection

When you cite a specific essay, chapter, or poem from an anthology or collection, you need to cite both the individual work and the larger collection. This requires two levels of citation: one for the specific piece and one for the book it's part of. This dual citation ensures that readers can find the exact part of the work you are referencing, as well as the source of the collection.

The format for a work within an anthology or collection is:

Last Name, First Name (Author of Chapter/Essay). "Title of Chapter/Essay." *Title of Anthology/Collection*, edited by First Name Last Name, Publisher, Year of Publication, pp. Page Numbers.

For instance:

Garcia, Maria. "The Power of Narrative." *New Voices in Fiction*, edited by Samuel Chen, University Press, 2023, pp. 45-62.

Pay close attention to the quotation marks around the title of the individual work and the italics for the title of the anthology.

Citing a Translated Book

Citing a translated book requires acknowledging both the original author and the translator. The translator's name is usually included after the title, often with the abbreviation "trans." This acknowledges the critical role of the translator in making the work accessible to a new audience and in potentially shaping the reader's understanding.

The format for a translated book is:

Last Name, First Name (Author). *Title of Book*. Translated by First Name Last Name, Publisher, Year of Publication.

An example:

Camus, Albert. *The Stranger*. Translated by Matthew Ward, Vintage International, 1988.

It is crucial to include the translator's name, especially if their translation is significant or widely recognized.

Citing a Revised Edition

When you consult a revised or updated edition of a book, it's important to indicate this in your citation. This is particularly relevant if the revisions have led to significant changes in content, pagination, or scholarly apparatus. Citing the correct edition helps readers locate the precise version of the text you have used, preventing confusion.

The format for a revised edition is:

Last Name, First Name. *Title of Book*. nd rev. ed., Publisher, Year of Publication.

Use "1st ed." for the first edition, "2nd ed." for the second, and so on. For example:

Darwin, Charles. *On the Origin of Species*. 6th ed., Modern Library, 2003.

The abbreviation "ed." is used for edition.

Citing a Book with a Corporate Author

Sometimes, the author of a book is not an individual but an organization, institution, or government agency. In these cases, the name of the corporate author is used in place of an individual's name. Ensure you use the full, official name of the organization.

The format for a corporate author is:

Corporate Author Name. *Title of Book*. Publisher, Year of Publication.

For example:

World Health Organization. *Global Health Report 2023*. WHO Press, 2023.

Be precise with the organization's name as it appears on the title page.

Citing an E-book

Citing an e-book requires similar information to a print book, but with the addition of information about the electronic format and access. MLA guidelines for e-books have evolved, and now often emphasize stability and discoverability.

The general format for an e-book is:

Last Name, First Name. *Title of E-book*. Publisher, Year of Publication. *Database Name* (if applicable), DOI or URL.

If the e-book is from a database, include the database name. If it is accessed via a direct URL, provide that. A Digital Object Identifier (DOI) is preferred if available.

Example:

Gaiman, Neil. *American Gods*. William Morrow, 2001. *Google Books*, books.google.com/books?id=l9tJDwAAQBAJ.

Always check for a DOI first, as it is a more stable identifier.

In-Text Citations for Books

In-text citations are brief references within your paper that direct readers to the full citation in your Works Cited list. For books, the most common form of in-text citation includes the author's last name and the page number(s) from which you are quoting or paraphrasing. This allows readers to quickly locate the source material.

The standard format for an in-text citation is:

(Author's Last Name Page Number)

For example:

(Smith 55)

If you have already mentioned the author's name in your sentence, you only need to include the page number:

Smith argues that "research is fundamental" (55).

For works with no author, you would use a shortened version of the title.

A: A bibliography entry (Works Cited page) provides full publication details for the source. An in-text citation is a brief parenthetical reference within your paper that includes the author's last name and page number, directing the reader to the full entry on the Works Cited page.

A: You would cite the author of the preface or introduction first, followed by the title of that specific section (in quotation marks), and then the title of the book (italicized). For example: Last Name, First Name (Author of Preface). "Title of Preface." *Title of Book*, by Main Author Last Name, Publisher, Year, pp. Page Numbers.
