The Reference List in the Author-Date System

For the author-date system, the in-text citation would be (Bloom 1973, 75). The corresponding reference list entry would begin with the author's name and the year: Bloom, Harold. 1973. *The Anxiety of Influence: A Theory of Poetry*. New York: Oxford University Press.

Citing Journal Articles in Chicago Style

Journal articles are crucial for engaging with current scholarship and critical perspectives on literature. Proper citation of these sources is vital for acknowledging the work of other scholars and allowing readers to access these often-specialized discussions.

In the notes-bibliography system, a note for a journal article would include the author's

name, the article title (in quotation marks), the journal title (italicized), volume and issue numbers, publication year, and page range for the article, followed by the specific page(s) cited. For instance: 2. Sandra M. Gilbert and Susan Gubar, "The Queen's Looking Glass: Female Mirrors and the Interiority of the 'Feminine'," *Representations* 1, no. 1 (Spring 1983): 90, accessed October 26, 2023, doi:10.1525/rep.1983.1.1.90a.

The bibliography entry would be: Gilbert, Sandra M., and Susan Gubar. "The Queen's Looking Glass: Female Mirrors and the Interiority of the 'Feminine'." *Representations* 1, no. 1 (Spring 1983): 85–103. doi:10.1525/rep.1983.1.1.90a.

For the author-date system, the in-text citation might be (Gilbert and Gubar 1983, 90). The reference list entry would look like: Gilbert, Sandra M., and Susan Gubar. 1983. "The Queen's Looking Glass: Female Mirrors and the Interiority of the 'Feminine'." *Representations* 1 (1): 85–103. doi:10.1525/rep.1983.1.1.90a.

Citing Websites and Online Sources in Chicago Style

The digital landscape has transformed how we access and engage with literature and its criticism. Citing websites and online sources in Chicago style requires careful attention to details that may differ from print sources, especially regarding access dates and URLs or DOIs.

When citing a website in a note, include the author (if available), the title of the specific page or article (in quotation marks), the website name (italicized), the publication date or last updated date, and the URL. Include an access date if the content is likely to change. For example: 3. For the author-date system, the in-text citation would be (Jane Austen Society of North America, n.d.). The reference list entry would be: Jane Austen Society of North America. n.d. "About the Author." Accessed October 26, 2023. <https://www.jasna.org/about-jasna/>.

Q: What is the purpose of the "accessed" date in online source citations in Chicago style?

A: The "accessed" date is crucial for online sources because web content can be updated or removed without notice. Including the access date indicates when you viewed the material, providing a point of reference if the source changes or becomes unavailable later. It is most important for sources that lack a clear publication date or are known to be dynamic.
