However, it also presents challenges through sophisticated surveillance, disinformation campaigns, algorithmic manipulation, and the potential for data exploitation, which can lead to new forms of psychological and social coercion and undermine individual autonomy.

Q: How can individuals contribute to upholding civil liberties and freedom from coercion?
