The Legal Foundation of Refugee Rights in the US

In immigration court, an immigration judge will review the case, hear testimony, and make a decision. Withholding of Removal and Protection Under the Convention Against Torture

Applicants for CAT protection must demonstrate a clear probability that they will be tortured, a high evidentiary standard that requires substantial proof.
