A staunch advocate of nonviolent protest, Lewis participated in numerous pivotal events, including the Freedom Rides and the Selma to Montgomery marches, where he was brutally beaten by state troopers on the Edmund Pettus Bridge during the "Bloody Sunday" protest. Ella Baker

Thurgood Marshall
