INTELLECTUAL INFLUENCES ON MARX AND ENGELS

ACADEMIC STUDIES EXPLORE HOW DIFFERENT FORMS OF CLASS STRUGGLE HAVE MANIFESTED THROUGHOUT HISTORY, FROM EARLY TRADE UNION MOVEMENTS TO MODERN-DAY LABOR DISPUTES AND POLITICAL ACTIVISM.
