The book clarifies how historical change is understood through the lens of evolving modes of production.

9. Theses on Feuerbach

These brief but profound notes by Karl Marx are considered a foundational statement of his break with earlier philosophy and a concise articulation of historical materialism. They emphasize the importance of practical, material activity in shaping human consciousness and history, famously stating, "The philosophers have only interpreted the world, in various ways; the point is to change it." These theses underscore the active, transformative aspect of the Marxist project.
