EMBARKING ON A CAREER AS A CORRECTIONAL OFFICER IS MORE THAN JUST TAKING A JOB; IT'S ABOUT STEPPING INTO A ROLE THAT DEMANDS UNWAVERING INTEGRITY, SHARP JUDGMENT, AND A PROFOUND COMMITMENT TO PUBLIC SAFETY. AT THE HEART OF THIS DEMANDING PROFESSION LIES CORRECTIONAL OFFICER BASIC TRAINING, A COMPREHENSIVE AND INDISPENSABLE PROGRAM THAT SERVES AS THE BEDROCK FOR ALL FUTURE ENDEAVORS WITHIN THE CORRECTIONAL SYSTEM. IT'S NOT MERELY A FORMALITY; IT'S A DEEP DIVE INTO THE REALITIES OF MANAGING INCARCERATED POPULATIONS AND MAINTAINING SECURITY. THIS TRAINING IS SPECIFICALLY ENGINEERED TO PREPARE INDIVIDUALS FOR THE UNIQUE CHALLENGES THEY WILL FACE, ENSURING THEY ARE NOT ONLY KNOWLEDGEABLE BUT ALSO RESILIENT AND CAPABLE.

THE IMPORTANCE OF THIS FOUNDATIONAL TRAINING CANNOT BE OVERSTATED. IT'S WHERE ASPIRING OFFICERS LEARN THE CRITICAL RULES, REGULATIONS, AND PROTOCOLS THAT GOVERN CORRECTIONAL FACILITIES. WITHOUT THIS SPECIALIZED EDUCATION, THE INHERENT RISKS ASSOCIATED WITH THE JOB WOULD BE EXPONENTIALLY HIGHER FOR BOTH OFFICERS AND INMATES. THINK OF IT AS THE PILOT'S INITIAL FLIGHT SCHOOL – ABSOLUTELY CRUCIAL BEFORE THEY EVER TAKE THE CONTROLS OF A COMMERCIAL AIRCRAFT. CORRECTIONAL OFFICER BASIC TRAINING INSTILLS A SENSE OF ORDER, FAIRNESS, AND AUTHORITY THAT IS PARAMOUNT IN MAINTAINING A SAFE AND SECURE ENVIRONMENT, PREVENTING INCIDENTS, AND RESPONDING EFFECTIVELY WHEN THEY DO OCCUR.

THE ESSENTIAL PILLARS OF CORRECTIONAL OFFICER BASIC TRAINING

CORRECTIONAL OFFICER BASIC TRAINING IS A MULTIFACETED PROGRAM DESIGNED TO COVER A WIDE SPECTRUM OF KNOWLEDGE AND SKILLS ESSENTIAL FOR EFFECTIVE AND SAFE DUTY. IT'S AN INTENSIVE CURRICULUM THAT LEAVES NO STONE UNTURNED, ENSURING THAT CADETS ARE WELL-PREPARED FOR THE REALITIES OF THE CORRECTIONAL ENVIRONMENT. THESE PILLARS ARE NOT INDEPENDENT BUT RATHER INTERCONNECTED, REINFORCING EACH OTHER TO CREATE A WELL-ROUNDED CORRECTIONAL OFFICER.

LEGAL FOUNDATIONS AND INMATE RIGHTS

A SIGNIFICANT PORTION OF CORRECTIONAL OFFICER BASIC TRAINING IS DEDICATED TO UNDERSTANDING THE LEGAL FRAMEWORK WITHIN WHICH CORRECTIONAL FACILITIES OPERATE. THIS INCLUDES EXTENSIVE STUDY OF CONSTITUTIONAL LAW, PARTICULARLY AMENDMENTS PERTAINING TO INCARCERATED INDIVIDUALS, SUCH AS THE EIGHTH AMENDMENT (CRUEL AND UNUSUAL PUNISHMENT) AND THE FOURTEENTH AMENDMENT (DUE PROCESS). OFFICERS MUST GRASP THE LEGAL RIGHTS OF

INMATES, UNDERSTANDING THAT WHILE THEIR LIBERTY IS RESTRICTED, THEY STILL POSSESS FUNDAMENTAL HUMAN AND LEGAL PROTECTIONS. THIS KNOWLEDGE IS VITAL FOR PREVENTING LAWSUITS, ENSURING FAIR TREATMENT, AND MAINTAINING THE LEGITIMACY OF THE CORRECTIONAL SYSTEM. CADETS LEARN ABOUT CASE LAW, ADMINISTRATIVE REGULATIONS, AND THE SPECIFIC POLICIES OF THE EMPLOYING AGENCY, ALL OF WHICH DICTATE OFFICER CONDUCT AND DECISION-MAKING.

SECURITY PROCEDURES AND FACILITY OPERATIONS

MAINTAINING A SECURE ENVIRONMENT IS THE PRIMARY RESPONSIBILITY OF ANY CORRECTIONAL OFFICER, AND BASIC TRAINING PROVIDES THE BLUEPRINT FOR ACHIEVING THIS. THIS INVOLVES LEARNING ABOUT PERIMETER SECURITY, CELL BLOCK MANAGEMENT, CONTRABAND DETECTION, AND THE PROPER USE OF SURVEILLANCE EQUIPMENT. CADETS ARE INSTRUCTED ON PROCEDURES FOR CONDUCTING SEARCHES OF INMATES, CELLS, AND COMMON AREAS, AS WELL AS PROTOCOLS FOR MANAGING INMATE MOVEMENT WITHIN THE FACILITY. UNDERSTANDING THE LAYOUT OF THE INSTITUTION, KEY CONTROL PROCEDURES, AND EMERGENCY LOCKDOWN PROTOCOLS ARE ALSO CRITICAL COMPONENTS. THIS TRAINING EMPHASIZES VIGILANCE AND ATTENTION TO DETAIL, AS EVEN MINOR OVERSIGHTS CAN HAVE SIGNIFICANT CONSEQUENCES IN A HIGH-SECURITY SETTING.

INTERPERSONAL SKILLS AND COMMUNICATION STRATEGIES

CORRECTIONAL OFFICERS INTERACT WITH A DIVERSE POPULATION OF INMATES DAILY, AND EFFECTIVE COMMUNICATION IS A NON-NEGOTIABLE SKILL. BASIC TRAINING INCORPORATES MODULES ON VERBAL DE-ESCALATION TECHNIQUES, ACTIVE LISTENING, AND CONFLICT RESOLUTION. OFFICERS LEARN HOW TO COMMUNICATE ASSERTIVELY AND RESPECTFULLY, BUILDING RAPPORT WHEN APPROPRIATE WHILE MAINTAINING PROFESSIONAL BOUNDARIES. THEY ARE TAUGHT TO RECOGNIZE AND RESPOND TO SIGNS OF STRESS, ANGER, OR POTENTIAL AGGRESSION IN INMATES. UNDERSTANDING NON-VERBAL CUES AND THE PSYCHOLOGY OF INMATES IS ALSO A KEY ELEMENT, HELPING OFFICERS TO ANTICIPATE AND DEFUSE POTENTIALLY VOLATILE SITUATIONS BEFORE THEY ESCALATE. THIS ASPECT OF TRAINING IS CRUCIAL FOR FOSTERING A MORE STABLE AND MANAGEABLE ENVIRONMENT.

USE OF FORCE AND SELF-DEFENSE TECHNIQUES

WHILE THE PRIMARY GOAL IS TO PREVENT THE NEED FOR FORCE, CORRECTIONAL OFFICER BASIC TRAINING INCLUDES COMPREHENSIVE INSTRUCTION ON THE APPROPRIATE AND LAWFUL USE OF FORCE. CADETS RECEIVE TRAINING IN DEFENSIVE TACTICS, INCLUDING PHYSICAL CONTROL TECHNIQUES, HANDCUFFING PROCEDURES, AND THE USE OF NON-LETHAL CONTROL DEVICES. THEY LEARN THE CONTINUUM OF FORCE, UNDERSTANDING WHEN AND HOW TO ESCALATE OR DE-ESCALATE THEIR RESPONSE BASED ON THE THREAT LEVEL. SCENARIO-BASED TRAINING IS EXTENSIVELY USED TO ALLOW CADETS TO PRACTICE THESE SKILLS IN SIMULATED SITUATIONS, REINFORCING THE PRINCIPLES OF PROPORTIONALITY AND NECESSITY. THIS TRAINING IS NOT ABOUT AGGRESSION BUT ABOUT OFFICER SAFETY AND THE ABILITY TO CONTROL DANGEROUS SITUATIONS EFFECTIVELY AND ETHICALLY.

EMERGENCY PREPAREDNESS AND RESPONSE

THE CORRECTIONAL ENVIRONMENT IS SUSCEPTIBLE TO A VARIETY OF EMERGENCIES, FROM MEDICAL CRISES AND FIRES TO RIOTS AND ESCAPES. CORRECTIONAL OFFICER BASIC TRAINING DEDICATES SIGNIFICANT TIME TO EMERGENCY PREPAREDNESS. CADETS ARE TRAINED IN FIRST AID AND CPR, LEARNING TO PROVIDE IMMEDIATE MEDICAL ASSISTANCE UNTIL PROFESSIONAL HELP ARRIVES. THEY LEARN PROTOCOLS FOR RESPONDING TO FIRES, INCLUDING EVACUATION PROCEDURES AND THE USE OF FIRE SUPPRESSION EQUIPMENT. IN THE EVENT OF A DISTURBANCE OR RIOT, OFFICERS ARE TRAINED IN CROWD CONTROL TECHNIQUES AND COORDINATED RESPONSE STRATEGIES. UNDERSTANDING EMERGENCY COMMUNICATION SYSTEMS AND REPORTING PROCEDURES IS ALSO A CRITICAL COMPONENT, ENSURING A SWIFT AND ORGANIZED RESPONSE TO ANY CRISIS.

NAVIGATING THE PHYSICAL AND MENTAL RIGORS OF TRAINING

CORRECTIONAL OFFICER BASIC TRAINING IS NOT FOR THE FAINT OF HEART. IT DEMANDS A SIGNIFICANT COMMITMENT OF BOTH PHYSICAL AND MENTAL FORTITUDE. CADETS ARE PUSHED TO THEIR LIMITS, BOTH INDIVIDUALLY AND AS A TEAM, TO PREPARE

THEM FOR THE STRESSES OF THE JOB. IT'S A TRANSFORMATIVE EXPERIENCE DESIGNED TO BUILD RESILIENCE, DISCIPLINE, AND THE ABILITY TO PERFORM UNDER PRESSURE.

PHYSICAL CONDITIONING AND READINESS

THE PHYSICAL DEMANDS OF A CORRECTIONAL OFFICER CAN BE SUBSTANTIAL, AND BASIC TRAINING REFLECTS THIS REALITY. EXPECT RIGOROUS PHYSICAL TRAINING DESIGNED TO IMPROVE STRENGTH, ENDURANCE, AND AGILITY. THIS OFTEN INCLUDES RUNNING, OBSTACLE COURSES, DEFENSIVE TACTICS DRILLS, AND STRENGTH CONDITIONING EXERCISES. CADETS MUST BE ABLE TO PHYSICALLY RESTRAIN INDIVIDUALS, PARTICIPATE IN PHYSICAL ALTERCATIONS IF NECESSARY, AND ENDURE LONG SHIFTS THAT MAY REQUIRE STANDING FOR EXTENDED PERIODS. A BASELINE LEVEL OF FITNESS IS TYPICALLY REQUIRED FOR ENTRY, AND THE TRAINING PROGRAM INTENSIFIES THIS, ENSURING THAT OFFICERS ARE PHYSICALLY CAPABLE OF HANDLING THE DEMANDS OF THE JOB AND PROTECTING THEMSELVES AND OTHERS.

MENTAL FORTITUDE AND STRESS MANAGEMENT

BEYOND THE PHYSICAL, THE MENTAL CHALLENGES OF CORRECTIONAL OFFICER BASIC TRAINING ARE EQUALLY, IF NOT MORE, DEMANDING. CADETS ARE EXPOSED TO SIMULATED STRESSFUL SCENARIOS, LECTURED ON THE PSYCHOLOGICAL IMPACTS OF CORRECTIONAL WORK, AND TAUGHT STRATEGIES FOR MANAGING STRESS, ANGER, AND FEAR. THE TRAINING ENVIRONMENT ITSELF CAN BE STRESSFUL, WITH DEMANDING INSTRUCTORS AND HIGH EXPECTATIONS. LEARNING TO MAINTAIN COMPOSURE IN THE FACE OF ADVERSITY, MAKE SOUND DECISIONS UNDER PRESSURE, AND DEVELOP EMOTIONAL RESILIENCE ARE PARAMOUNT. THIS MENTAL CONDITIONING IS CRUCIAL FOR PREVENTING BURNOUT AND ENSURING THAT OFFICERS CAN PERFORM THEIR DUTIES EFFECTIVELY AND ETHICALLY EVEN IN THE MOST CHALLENGING CIRCUMSTANCES.

DISCIPLINE, TEAMWORK, AND ACCOUNTABILITY

A CORE TENET OF CORRECTIONAL OFFICER BASIC TRAINING IS THE INSTILLATION OF DISCIPLINE AND A STRONG SENSE OF ACCOUNTABILITY. CADETS LEARN THE IMPORTANCE OF FOLLOWING ORDERS, ADHERING TO STRICT PROTOCOLS, AND WORKING COLLABORATIVELY WITH THEIR PEERS. TEAMWORK IS EMPHASIZED HEAVILY, AS OFFICERS MUST RELY ON EACH OTHER DURING EMERGENCIES AND DAY-TO-DAY OPERATIONS. THE TRAINING OFTEN INVOLVES TEAM-BUILDING EXERCISES AND SIMULATIONS THAT REQUIRE COORDINATED EFFORTS. THIS FOCUS ON DISCIPLINE AND ACCOUNTABILITY PREPARES OFFICERS TO OPERATE WITHIN A STRUCTURED HIERARCHY AND TO UNDERSTAND THE GRAVITY OF THEIR ACTIONS AND THEIR IMPACT ON THE OVERALL SAFETY AND SECURITY OF THE INSTITUTION.

THE TRAJECTORY OF A CORRECTIONAL OFFICER: FROM BASIC TRAINING TO ADVANCED ROLES

COMPLETING CORRECTIONAL OFFICER BASIC TRAINING IS NOT THE END OF THE LEARNING JOURNEY; IT IS MERELY THE BEGINNING. THIS FOUNDATIONAL EXPERIENCE OPENS DOORS TO A FULFILLING CAREER WITH OPPORTUNITIES FOR GROWTH AND SPECIALIZATION WITHIN THE CORRECTIONS FIELD.

INITIAL DEPLOYMENT AND ON-THE-JOB LEARNING

UPON SUCCESSFUL COMPLETION OF BASIC TRAINING, OFFICERS ARE TYPICALLY ASSIGNED TO A CORRECTIONAL FACILITY. THE INITIAL PERIOD IS OFTEN CHARACTERIZED BY ON-THE-JOB LEARNING, WHERE SEASONED OFFICERS PROVIDE MENTORSHIP AND GUIDANCE. NEW OFFICERS GAIN PRACTICAL EXPERIENCE, APPLYING THE PRINCIPLES LEARNED IN TRAINING TO REAL-WORLD SITUATIONS. THIS PHASE IS CRITICAL FOR SOLIDIFYING KNOWLEDGE AND DEVELOPING THE PRACTICAL SKILLS NEEDED FOR DAILY OPERATIONS. THE ENVIRONMENT ITSELF IS A CONSTANT TEACHER, PRESENTING NEW CHALLENGES AND SCENARIOS THAT HONE AN OFFICER'S JUDGMENT AND DECISION-MAKING CAPABILITIES.

OPPORTUNITIES FOR SPECIALIZATION AND ADVANCEMENT

AS OFFICERS GAIN EXPERIENCE, THEY MAY PURSUE OPPORTUNITIES FOR SPECIALIZATION AND ADVANCEMENT. THIS CAN INCLUDE ROLES SUCH AS:

- GANG INTELLIGENCE OFFICERS
- K-9 UNIT OFFICERS
- CORRECTIONAL COUNSELORS
- INVESTIGATIVE STAFF
- UNIT MANAGERS
- SWAT (SPECIAL WEAPONS AND TACTICS) TEAMS
- TRAINING INSTRUCTORS

MANY CORRECTIONAL AGENCIES OFFER FURTHER IN-SERVICE TRAINING AND PROFESSIONAL DEVELOPMENT PROGRAMS TO EQUIP OFFICERS WITH THE SKILLS NEEDED FOR THESE ADVANCED ROLES. CONTINUED EDUCATION AND A COMMITMENT TO PROFESSIONAL GROWTH ARE KEY TO ADVANCING A CAREER IN CORRECTIONS.

THE INDISPENSABLE FOUNDATION: WHY CORRECTIONAL OFFICER BASIC TRAINING MATTERS

IN ESSENCE, CORRECTIONAL OFFICER BASIC TRAINING IS FAR MORE THAN JUST A PREREQUISITE FOR EMPLOYMENT; IT IS THE FUNDAMENTAL BUILDING BLOCK UPON WHICH A SAFE, SECURE, AND HUMANE CORRECTIONAL SYSTEM IS BUILT. IT IMBUES INDIVIDUALS WITH THE KNOWLEDGE, SKILLS, AND ETHICAL COMPASS NECESSARY TO CONFRONT THE IMMENSE CHALLENGES OF MANAGING INCARCERATED POPULATIONS. WITHOUT THIS RIGOROUS PREPARATION, THE INTEGRITY OF CORRECTIONAL FACILITIES AND THE SAFETY OF BOTH STAFF AND INMATES WOULD BE SEVERELY COMPROMISED. IT IS A TESTAMENT TO THE SERIOUSNESS OF THIS PROFESSION AND THE DEDICATION REQUIRED TO EXCEL WITHIN IT.

THE TRAINING INSTILLS A SENSE OF PROFESSIONALISM AND ACCOUNTABILITY THAT IS CRUCIAL FOR MAINTAINING ORDER AND RESPECT WITHIN CORRECTIONAL INSTITUTIONS. IT EQUIPS OFFICERS WITH THE TOOLS TO DE-ESCALATE CONFLICT, ENFORCE RULES FAIRLY, AND RESPOND EFFECTIVELY TO EMERGENCIES, ALL WHILE UPHOLDING THE RIGHTS AND DIGNITY OF INDIVIDUALS IN THEIR CARE. FOR ANYONE CONSIDERING A CAREER IN CORRECTIONS, UNDERSTANDING AND EMBRACING THE COMPREHENSIVE NATURE OF CORRECTIONAL OFFICER BASIC TRAINING IS THE ESSENTIAL FIRST STEP TOWARDS A MEANINGFUL AND IMPACTFUL PUBLIC SERVICE.

FAQ

Q: WHAT IS THE TYPICAL DURATION OF CORRECTIONAL OFFICER BASIC TRAINING?

A: THE DURATION OF CORRECTIONAL OFFICER BASIC TRAINING CAN VARY SIGNIFICANTLY DEPENDING ON THE SPECIFIC AGENCY (STATE, FEDERAL, OR LOCAL) AND THE JURISDICTION. GENERALLY, BASIC TRAINING PROGRAMS CAN RANGE FROM A FEW WEEKS TO SEVERAL MONTHS, WITH MANY LASTING BETWEEN 8 TO 16 WEEKS. SOME MORE INTENSIVE FEDERAL PROGRAMS MIGHT EXTEND EVEN LONGER.

Q: WHAT ARE THE PHYSICAL FITNESS REQUIREMENTS FOR CORRECTIONAL OFFICER BASIC TRAINING?

A: PHYSICAL FITNESS REQUIREMENTS ARE A CRITICAL COMPONENT OF CORRECTIONAL OFFICER BASIC TRAINING. APPLICANTS ARE TYPICALLY REQUIRED TO PASS A PHYSICAL FITNESS ASSESSMENT BEFORE ENTERING TRAINING, WHICH MAY INCLUDE TESTS FOR CARDIOVASCULAR ENDURANCE (E.G., TIMED RUN), MUSCULAR STRENGTH (E.G., PUSH-UPS, SIT-UPS), AND FLEXIBILITY. DURING TRAINING, PHYSICAL CONDITIONING IS INTENSE, FOCUSING ON STRENGTH, AGILITY, AND STAMINA TO PREPARE OFFICERS FOR THE DEMANDS OF THE JOB.

Q: WILL I BE TAUGHT HOW TO USE FIREARMS DURING CORRECTIONAL OFFICER BASIC TRAINING?

A: YES, MANY CORRECTIONAL OFFICER BASIC TRAINING PROGRAMS INCLUDE INSTRUCTION ON THE SAFE AND PROFICIENT USE OF FIREARMS. WHILE NOT ALL CORRECTIONAL OFFICERS ARE ROUTINELY ARMED WITHIN THE FACILITY, ALL OFFICERS ARE TRAINED TO HANDLE FIREARMS AND UNDERSTAND THEIR ROLE IN SECURITY PROTOCOLS AND EMERGENCY SITUATIONS. THE SPECIFIC FIREARMS TRAINING WILL DEPEND ON THE POLICIES OF THE EMPLOYING AGENCY.

Q: WHAT KIND OF PSYCHOLOGICAL EVALUATION IS INVOLVED IN THE CORRECTIONAL OFFICER HIRING AND TRAINING PROCESS?

A: A COMPREHENSIVE PSYCHOLOGICAL EVALUATION IS A STANDARD PART OF THE HIRING PROCESS FOR CORRECTIONAL OFFICERS. THIS TYPICALLY INCLUDES A WRITTEN PSYCHOLOGICAL TEST AND AN INTERVIEW WITH A PSYCHOLOGIST OR PSYCHIATRIST. THE EVALUATION ASSESSES AN INDIVIDUAL'S MENTAL STABILITY, EMOTIONAL MATURITY, DECISION-MAKING ABILITIES, AND SUITABILITY FOR THE HIGH-STRESS ENVIRONMENT OF A CORRECTIONAL FACILITY. THIS IS TO ENSURE OFFICERS CAN HANDLE THE PRESSURES OF THE JOB WITHOUT COMPROMISING SAFETY OR THEIR OWN WELL-BEING.

Q: HOW IMPORTANT ARE COMMUNICATION AND DE-ESCALATION SKILLS IN CORRECTIONAL OFFICER BASIC TRAINING?

A: COMMUNICATION AND DE-ESCALATION SKILLS ARE PARAMOUNT IN CORRECTIONAL OFFICER BASIC TRAINING. A SIGNIFICANT PORTION OF THE CURRICULUM FOCUSES ON TEACHING OFFICERS HOW TO EFFECTIVELY COMMUNICATE WITH INMATES, MANAGE CONFLICTS VERBALLY, AND DE-ESCALATE POTENTIALLY VIOLENT SITUATIONS. THESE SKILLS ARE CRUCIAL FOR MAINTAINING ORDER, PREVENTING INCIDENTS, AND ENSURING THE SAFETY OF BOTH STAFF AND INMATES.

Q: IS THERE A SPECIFIC ACADEMIC OR EDUCATIONAL REQUIREMENT TO BEGIN CORRECTIONAL OFFICER BASIC TRAINING?

A: YES, MOST CORRECTIONAL AGENCIES REQUIRE A MINIMUM EDUCATIONAL LEVEL TO BE CONSIDERED FOR EMPLOYMENT AND ENTRY INTO BASIC TRAINING. THIS OFTEN INCLUDES A HIGH SCHOOL DIPLOMA OR GED. SOME POSITIONS OR AGENCIES MAY PREFER OR REQUIRE SOME COLLEGE COURSEWORK OR AN ASSOCIATE'S OR BACHELOR'S DEGREE IN A RELATED FIELD SUCH AS CRIMINAL JUSTICE, PSYCHOLOGY, OR SOCIOLOGY.

Q: WHAT HAPPENS IF I FAIL A PORTION OF THE CORRECTIONAL OFFICER BASIC TRAINING?

A: FAILING A PORTION OF CORRECTIONAL OFFICER BASIC TRAINING CAN LEAD TO VARIOUS OUTCOMES, DEPENDING ON THE AGENCY'S POLICIES AND THE NATURE OF THE FAILURE. IN SOME CASES, CADETS MAY BE GIVEN OPPORTUNITIES FOR REMEDIATION OR RETESTING. HOWEVER, IF A CADET CONSISTENTLY FAILS TO MEET THE STANDARDS OR FAILS A CRITICAL COMPONENT OF THE TRAINING, THEY MAY BE DISMISSED FROM THE PROGRAM AND DISQUALIFIED FROM EMPLOYMENT.

Q: CAN I EXPECT TO LEARN ABOUT INMATE CLASSIFICATION AND MANAGEMENT AS PART OF BASIC TRAINING?

A: ABSOLUTELY. CORRECTIONAL OFFICER BASIC TRAINING INCLUDES COMPREHENSIVE INSTRUCTION ON INMATE CLASSIFICATION SYSTEMS AND MANAGEMENT STRATEGIES. THIS INVOLVES UNDERSTANDING HOW INMATES ARE CATEGORIZED BASED ON SECURITY RISK, OFFENSE HISTORY, AND OTHER FACTORS, AND HOW TO MANAGE THEM ACCORDINGLY WITHIN THE FACILITY. LEARNING ABOUT DIFFERENT SECURITY LEVELS AND THE PROTOCOLS ASSOCIATED WITH EACH IS A CORE PART OF THE TRAINING CURRICULUM.
