FORENSIC SCIENCE AND DIGITAL EVIDENCE ANALYSIS

FURTHERMORE, ADVANCEMENTS IN DNA TECHNOLOGY, SUCH AS RAPID DNA ANALYSIS AND THE ABILITY TO INFER PHYSICAL CHARACTERISTICS FROM GENETIC MATERIAL, ARE REVOLUTIONIZING COLD CASE INVESTIGATIONS AND IDENTIFYING SUSPECTS WITH GREATER SPEED AND ACCURACY.
