FROM TACKLING MASS INCARCERATION AND RACIAL DISPARITIES TO FOCUSING ON POLICE ACCOUNTABILITY AND VICTIM SUPPORT, THEIR EFFORTS ARE MULTIFACETED AND DEEPLY IMPACTFUL. THIS ARTICLE WILL DELVE INTO THE VITAL WORK OF THESE GROUPS, EXPLORING THEIR DIVERSE STRATEGIES, KEY AREAS OF FOCUS, AND THE TANGIBLE RESULTS THEY ARE ACHIEVING ACROSS THE UNITED STATES. WHAT IS CRIMINAL JUSTICE REFORM?

CRIMINAL JUSTICE REFORM REFERS TO THE ONGOING EFFORTS TO CREATE A FAIRER, MORE EFFECTIVE, AND MORE HUMANE SYSTEM FOR DEALING WITH CRIME AND ITS CONSEQUENCES. AT ITS CORE, IT QUESTIONS WHETHER THE CURRENT PRACTICES AND LAWS TRULY SERVE JUSTICE, PROMOTE PUBLIC SAFETY, AND OFFER PATHWAYS TO REDEMPTION AND REINTEGRATION. THE NEED FOR REFORM ARISES FROM A MULTITUDE OF ISSUES THAT HAVE BECOME INCREASINGLY APPARENT OVER DECADES, INCLUDING OVERCROWDING IN PRISONS, DISPROPORTIONATE SENTENCING, RACIAL BIASES, AND A LACK OF FOCUS ON REHABILITATION AND ADDRESSING THE ROOT CAUSES OF CRIME.

HISTORICALLY, THE US CRIMINAL JUSTICE SYSTEM HAS OFTEN PRIORITIZED PUNISHMENT OVER ALL ELSE. THIS HAS LED TO AN EXPLOSION IN THE INCARCERATED POPULATION, THE HIGHEST PER CAPITA IN THE WORLD, WITH PROFOUND SOCIAL AND ECONOMIC COSTS. REFORM SEEKS TO SHIFT THIS PARADIGM, ADVOCATING FOR APPROACHES THAT ARE NOT ONLY PUNITIVE BUT ALSO RESTORATIVE, REHABILITATIVE, AND PREVENTATIVE. IT'S ABOUT ENSURING THAT THE SYSTEM TREATS EVERYONE EQUITABLY, REGARDLESS OF THEIR BACKGROUND, AND THAT IT GENUINELY AIMS TO REDUCE RECIDIVISM AND BUILD SAFER COMMUNITIES FOR EVERYONE.

THE IMPORTANCE OF ADVOCACY GROUPS IN CRIMINAL JUSTICE REFORM

WITHOUT DEDICATED ADVOCACY GROUPS, THE PUSH FOR CRIMINAL JUSTICE REFORM WOULD LIKELY FALTER. THESE ORGANIZATIONS ACT AS CRUCIAL CATALYSTS, BRINGING ATTENTION TO SYSTEMIC PROBLEMS, MOBILIZING PUBLIC OPINION, AND DIRECTLY ENGAGING WITH POLICYMAKERS. THEY ARE THE VOICE FOR THOSE WHO HAVE BEEN MARGINALIZED BY THE SYSTEM AND OFTEN LACK THE POWER TO SPEAK FOR THEMSELVES. THEIR PERSISTENT EFFORTS ARE ESSENTIAL FOR DRIVING LEGISLATIVE CHANGES, CHALLENGING OUTDATED POLICIES, AND ENSURING THAT REFORMS ARE IMPLEMENTED EFFECTIVELY AND EQUITABLY.

ADVOCACY GROUPS PLAY A MULTIFACETED ROLE. THEY CONDUCT VITAL RESEARCH TO HIGHLIGHT DISPARITIES AND INEFFICIENCIES, EDUCATE THE PUBLIC ABOUT COMPLEX LEGAL AND SOCIAL ISSUES, AND LOBBY ELECTED OFFICIALS TO ENACT MEANINGFUL LEGISLATION. FURTHERMORE, THEY OFTEN PROVIDE DIRECT SUPPORT TO INDIVIDUALS IMPACTED BY THE JUSTICE SYSTEM, OFFERING LEGAL AID, REENTRY SERVICES, AND A PLATFORM FOR THEIR EXPERIENCES. THEIR COLLECTIVE POWER CAN TRANSFORM PUBLIC DISCOURSE AND CREATE THE POLITICAL WILL NECESSARY FOR PROFOUND CHANGE.

KEY AREAS OF FOCUS FOR US ADVOCACY GROUPS

THE SCOPE OF CRIMINAL JUSTICE REFORM IS VAST, AND ADVOCACY GROUPS CONCENTRATE THEIR EFFORTS ON SEVERAL CRITICAL AREAS. THESE ISSUES ARE OFTEN INTERCONNECTED, AND PROGRESS IN ONE AREA CAN HAVE RIPPLE EFFECTS THROUGHOUT THE SYSTEM. UNDERSTANDING THESE FOCAL POINTS IS KEY TO APPRECIATING THE BREADTH AND DEPTH OF THE REFORM MOVEMENT.

ENDING MASS INCARCERATION

ONE OF THE MOST PROMINENT GOALS OF CRIMINAL JUSTICE REFORM ADVOCACY IS TO SIGNIFICANTLY REDUCE THE NUMBER OF PEOPLE INCARCERATED IN THE UNITED STATES. THIS INVOLVES ADVOCATING FOR SENTENCING REFORM, SUCH AS ENDING MANDATORY MINIMUMS, PROMOTING ALTERNATIVES TO INCARCERATION FOR NON-VIOLENT OFFENSES, AND REVISITING DRUG LAWS THAT HAVE CONTRIBUTED TO DISPROPORTIONATELY HIGH PRISON POPULATIONS. THE SHEER SCALE OF INCARCERATION IN THE US IS A GLOBAL ANOMALY, AND ADVOCACY GROUPS ARE WORKING TO DISMANTLE THE POLICIES THAT HAVE FUELED THIS TREND, RECOGNIZING THE DEVASTATING IMPACT ON FAMILIES AND COMMUNITIES.

ADDRESSING RACIAL DISPARITIES

IT IS UNDENIABLE THAT RACIAL AND ETHNIC MINORITIES ARE DISPROPORTIONATELY REPRESENTED AT EVERY STAGE OF THE CRIMINAL JUSTICE SYSTEM, FROM ARREST TO SENTENCING AND INCARCERATION. ADVOCACY GROUPS ARE AT THE FOREFRONT OF DEMANDING ACCOUNTABILITY FOR THESE SYSTEMIC BIASES. THEY PUSH FOR POLICY CHANGES THAT ELIMINATE RACIAL PROFILING, ENSURE FAIR POLICING PRACTICES, AND ADDRESS THE HISTORICAL LEGACIES OF DISCRIMINATION THAT CONTINUE TO PERMEATE THE JUSTICE SYSTEM. THEIR WORK OFTEN INVOLVES COLLECTING DATA, RAISING PUBLIC AWARENESS, AND ADVOCATING FOR LEGISLATION AIMED AT ACHIEVING RACIAL EQUITY.

POLICE ACCOUNTABILITY AND REFORM

THE RELATIONSHIP BETWEEN LAW ENFORCEMENT AND THE COMMUNITIES THEY SERVE IS A CENTRAL CONCERN FOR MANY ADVOCACY GROUPS. THEY ADVOCATE FOR GREATER TRANSPARENCY, IMPROVED TRAINING, AND STRICTER OVERSIGHT OF POLICE DEPARTMENTS. THIS INCLUDES CALLS FOR DEMILITARIZATION OF POLICE FORCES, DE-ESCALATION TRAINING, INDEPENDENT CIVILIAN REVIEW BOARDS, AND REFORMS TO USE-OF-FORCE POLICIES. THE GOAL IS TO FOSTER TRUST BETWEEN COMMUNITIES AND POLICE, ENSURING THAT LAW ENFORCEMENT OPERATES WITH FAIRNESS AND RESPECT FOR CIVIL LIBERTIES.

REHABILITATION AND REENTRY PROGRAMS

BEYOND PUNISHMENT, A CRUCIAL ASPECT OF REFORM INVOLVES FOCUSING ON REHABILITATION AND SUCCESSFUL REENTRY FOR INDIVIDUALS RETURNING TO SOCIETY AFTER INCARCERATION. ADVOCACY GROUPS CHAMPION PROGRAMS THAT PROVIDE EDUCATION, JOB TRAINING, MENTAL HEALTH SERVICES, AND SUBSTANCE ABUSE TREATMENT. THEY ADVOCATE FOR POLICIES THAT REMOVE BARRIERS TO EMPLOYMENT AND HOUSING FOR FORMERLY INCARCERATED INDIVIDUALS, RECOGNIZING THAT SUCCESSFUL REINTEGRATION IS KEY TO REDUCING RECIDIVISM AND CREATING SAFER COMMUNITIES. THIS FOCUS SHIFTS THE NARRATIVE FROM SOLELY PUNITIVE MEASURES TO ONE OF RESTORATION AND OPPORTUNITY.

VICTIM SUPPORT AND RESTORATIVE JUSTICE

WHILE OFTEN FOCUSED ON THOSE WITHIN THE SYSTEM, MANY ADVOCACY GROUPS ALSO PRIORITIZE THE NEEDS AND PERSPECTIVES OF CRIME VICTIMS. THEY ADVOCATE FOR COMPREHENSIVE VICTIM SUPPORT SERVICES, INCLUDING COUNSELING, FINANCIAL ASSISTANCE, AND A GREATER ROLE IN THE JUSTICE PROCESS. FURTHERMORE, SOME GROUPS CHAMPION RESTORATIVE JUSTICE APPROACHES, WHICH AIM TO REPAIR HARM AND FOSTER HEALING FOR BOTH VICTIMS AND OFFENDERS, OFTEN THROUGH DIALOGUE AND MEDIATION. THIS HOLISTIC APPROACH SEEKS TO ADDRESS THE BROADER IMPACT OF CRIME ON INDIVIDUALS AND COMMUNITIES.

STRATEGIES EMPLOYED BY ADVOCACY GROUPS

TO ACHIEVE THEIR AMBITIOUS GOALS, CRIMINAL JUSTICE REFORM ADVOCACY GROUPS IN THE US UTILIZE A DIVERSE ARRAY OF STRATEGIES. THESE METHODS ARE OFTEN EMPLOYED IN COMBINATION TO MAXIMIZE THEIR IMPACT AND REACH DIFFERENT AUDIENCES, FROM GRASSROOTS SUPPORTERS TO HIGH-LEVEL POLICYMAKERS. UNDERSTANDING THESE TACTICS PROVIDES INSIGHT INTO THE EFFECTIVENESS AND REACH OF THE REFORM MOVEMENT.

- **LOBBYING AND POLICY ADVOCACY:** DIRECT ENGAGEMENT WITH LEGISLATORS AT LOCAL, STATE, AND FEDERAL LEVELS TO PROPOSE, SUPPORT, OR OPPOSE SPECIFIC LEGISLATION. THIS OFTEN INVOLVES DRAFTING BILLS, TESTIFYING AT HEARINGS, AND BUILDING RELATIONSHIPS WITH LAWMAKERS.
- **PUBLIC EDUCATION AND AWARENESS CAMPAIGNS:** UTILIZING MEDIA, SOCIAL MEDIA, EVENTS, AND PUBLICATIONS TO INFORM THE PUBLIC ABOUT ISSUES WITHIN THE CRIMINAL JUSTICE SYSTEM AND GARNER SUPPORT FOR REFORM. THIS INCLUDES SHARING PERSONAL STORIES, DATA, AND RESEARCH.
- **LEGAL CHALLENGES AND LITIGATION:** FILING LAWSUITS AND ENGAGING IN STRATEGIC LITIGATION TO CHALLENGE UNCONSTITUTIONAL LAWS OR PRACTICES AND TO PUSH FOR SYSTEMIC CHANGE THROUGH THE COURTS.
- **COMMUNITY ORGANIZING AND MOBILIZATION:** BUILDING COALITIONS WITH OTHER ORGANIZATIONS AND MOBILIZING COMMUNITIES TO PARTICIPATE IN ADVOCACY EFFORTS, PROTESTS, AND VOTER REGISTRATION DRIVES.
- **RESEARCH AND DATA ANALYSIS:** CONDUCTING AND DISSEMINATING RESEARCH TO HIGHLIGHT PROBLEMS, PROVIDE EVIDENCE FOR POLICY RECOMMENDATIONS, AND TRACK THE IMPACT OF REFORMS.
- **DIRECT SERVICES AND SUPPORT:** PROVIDING TANGIBLE ASSISTANCE TO INDIVIDUALS AFFECTED BY THE JUSTICE SYSTEM, SUCH AS LEGAL AID, REENTRY SUPPORT, AND ADVOCACY FOR FAMILY MEMBERS.

NOTABLE CRIMINAL JUSTICE REFORM ADVOCACY GROUPS IN THE US

THE LANDSCAPE OF CRIMINAL JUSTICE REFORM ADVOCACY IN THE US IS POPULATED BY A MULTITUDE OF IMPACTFUL ORGANIZATIONS, EACH WITH ITS UNIQUE MISSION AND AREAS OF EXPERTISE. WHILE IT'S IMPOSSIBLE TO LIST THEM ALL, HIGHLIGHTING A FEW PROMINENT EXAMPLES SHOWCASES THE BREADTH AND DEDICATION WITHIN THE MOVEMENT.

ACLU (AMERICAN CIVIL LIBERTIES UNION)

THE ACLU IS A GIANT IN THE ADVOCACY SPACE, WITH A LONG HISTORY OF DEFENDING CIVIL RIGHTS AND LIBERTIES. THEIR CRIMINAL JUSTICE WORK FOCUSES ON ISSUES LIKE POLICE MISCONDUCT, WRONGFUL CONVICTIONS, THE DEATH PENALTY, AND PRISON CONDITIONS. THEY USE LITIGATION, LOBBYING, AND PUBLIC EDUCATION TO ADVANCE THEIR AGENDA, OFTEN TAKING ON LANDMARK CASES THAT SHAPE LEGAL PRECEDENT.

THE SENTENCING PROJECT

THIS ORGANIZATION IS DEDICATED TO REDUCING PRISON OVERCROWDING AND ELIMINATING RACIAL DISPARITIES IN THE JUSTICE SYSTEM. THE SENTENCING PROJECT CONDUCTS IN-DEPTH RESEARCH AND ADVOCATES FOR POLICY CHANGES RELATED TO SENTENCING LAWS, DRUG POLICY, AND RACIAL JUSTICE. THEY ARE A KEY SOURCE OF DATA AND ANALYSIS FOR POLICYMAKERS AND THE PUBLIC ALIKE.

VERA INSTITUTE OF JUSTICE

THE VERA INSTITUTE OF JUSTICE WORKS ON A WIDE RANGE OF CRIMINAL JUSTICE ISSUES, FROM IMPROVING POLICING AND REDUCING INCARCERATION TO STRENGTHENING REENTRY SERVICES AND PROMOTING ALTERNATIVES TO DETENTION. THEY ARE KNOWN FOR THEIR EVIDENCE-BASED APPROACH, CONDUCTING RESEARCH AND PILOTING INNOVATIVE PROGRAMS THAT CAN THEN BE SCALED UP.

FAMM (FAMILIES AGAINST MANDATORY MINIMUMS)

AS THEIR NAME SUGGESTS, FAMM IS A LEADING VOICE AGAINST DRACONIAN MANDATORY MINIMUM SENTENCING LAWS. THEY ADVOCATE FOR JUDICIAL DISCRETION AND REHABILITATION, FOCUSING ON HOW THESE RIGID SENTENCING STRUCTURES CAN LEAD TO UNJUST OUTCOMES AND CONTRIBUTE TO MASS INCARCERATION. THEIR WORK OFTEN INVOLVES SHARING THE POWERFUL STORIES OF FAMILIES IMPACTED BY THESE LAWS.

ACRJ (ALLIANCE OF COMMUNITIES FOR CRIMINAL JUSTICE REFORM)

THIS GROUP, AND OTHERS LIKE IT, OFTEN REPRESENTS A MORE LOCALIZED OR COMMUNITY-BASED APPROACH TO REFORM. THEY WORK TO EMPOWER COMMUNITIES DIRECTLY AFFECTED BY THE JUSTICE SYSTEM, BRINGING THEIR VOICES TO THE FOREFRONT OF POLICY DISCUSSIONS AND ADVOCATING FOR SOLUTIONS THAT ARE ROOTED IN LOCAL NEEDS AND EXPERIENCES.

CHALLENGES FACED BY ADVOCACY GROUPS

DESPITE THEIR VITAL WORK, CRIMINAL JUSTICE REFORM ADVOCACY GROUPS IN THE US FACE SIGNIFICANT HURDLES. THE DEEPLY ENTRENCHED NATURE OF THE CURRENT SYSTEM, COUPLED WITH COMPLEX POLITICAL LANDSCAPES AND DIFFERING PUBLIC OPINIONS, CREATES A CHALLENGING ENVIRONMENT FOR PROGRESS. OVERCOMING THESE OBSTACLES REQUIRES RESILIENCE, STRATEGIC PLANNING, AND A PERSISTENT COMMITMENT TO THEIR CAUSE.

ONE OF THE PRIMARY CHALLENGES IS THE SHEER POLITICAL INERTIA SURROUNDING CRIMINAL JUSTICE REFORM. MANY POLICIES HAVE BEEN IN PLACE FOR DECADES, AND VESTED INTERESTS CAN RESIST CHANGE. FURTHERMORE, PUBLIC PERCEPTION CAN BE A COMPLEX TERRAIN. WHILE THERE IS GROWING SUPPORT FOR REFORM, FEAR OF CRIME AND A PUNITIVE MINDSET CAN STILL SWAY PUBLIC OPINION AND INFLUENCE LEGISLATIVE DECISIONS. RESOURCE LIMITATIONS ARE ALSO A CONSTANT CONCERN; ADVOCACY GROUPS OFTEN OPERATE WITH TIGHT BUDGETS, RELYING HEAVILY ON DEDICATED STAFF AND VOLUNTEERS TO ACHIEVE THEIR GOALS.

ANOTHER SIGNIFICANT CHALLENGE LIES IN THE COMPLEXITY OF THE CRIMINAL JUSTICE SYSTEM ITSELF. UNDERSTANDING AND NAVIGATING THE INTRICATE WEB OF LAWS, AGENCIES, AND PROCEDURES REQUIRES SPECIALIZED KNOWLEDGE. THIS COMPLEXITY CAN BE A BARRIER TO PUBLIC UNDERSTANDING AND CAN ALSO MAKE IT DIFFICULT TO IDENTIFY AND IMPLEMENT EFFECTIVE REFORMS. FINALLY, MEASURING THE DIRECT IMPACT OF ADVOCACY EFFORTS CAN SOMETIMES BE CHALLENGING, AS REFORMS OFTEN TAKE YEARS TO BE FULLY IMPLEMENTED AND THEIR EFFECTS TO BECOME APPARENT.

THE CRIMINAL JUSTICE REFORM MOVEMENT IS A POWERFUL TESTAMENT TO THE POSSIBILITY OF POSITIVE CHANGE. ADVOCACY GROUPS IN THE US ARE NOT JUST PUSHING FOR INCREMENTAL ADJUSTMENTS; THEY ARE STRIVING FOR A FUNDAMENTAL REIMAGINING OF HOW SOCIETY ADDRESSES CRIME AND JUSTICE. THEIR DEDICATION TO RESEARCH, PUBLIC ENGAGEMENT, AND LEGISLATIVE ACTION IS CRUCIAL IN DISMANTLING OUTDATED SYSTEMS AND BUILDING A FUTURE THAT IS MORE EQUITABLE, HUMANE, AND EFFECTIVE FOR EVERYONE. THE ONGOING DIALOGUE AND THE TANGIBLE PROGRESS BEING MADE ARE A CLEAR INDICATION THAT THE TIRELESS EFFORTS OF THESE GROUPS ARE YIELDING SIGNIFICANT RESULTS, PAVING THE WAY FOR A MORE JUST SOCIETY.

FAQ

Q: WHAT IS THE PRIMARY GOAL OF CRIMINAL JUSTICE REFORM ADVOCACY GROUPS IN THE US?

A: THE PRIMARY GOAL OF CRIMINAL JUSTICE REFORM ADVOCACY GROUPS IN THE US IS TO CREATE A FAIRER, MORE EFFECTIVE, AND MORE HUMANE SYSTEM FOR ADDRESSING CRIME, PUNISHMENT, AND REHABILITATION. THIS OFTEN INVOLVES ADVOCATING FOR AN END TO MASS INCARCERATION, ADDRESSING RACIAL DISPARITIES, PROMOTING POLICE ACCOUNTABILITY, AND IMPROVING REENTRY PROGRAMS FOR FORMERLY INCARCERATED INDIVIDUALS.

Q: HOW DO CRIMINAL JUSTICE REFORM ADVOCACY GROUPS TYPICALLY INFLUENCE POLICY?

A: THESE GROUPS INFLUENCE POLICY THROUGH A VARIETY OF METHODS, INCLUDING LOBBYING LAWMAKERS, CONDUCTING PUBLIC AWARENESS CAMPAIGNS, ENGAGING IN LITIGATION, ORGANIZING COMMUNITY SUPPORT, AND PROVIDING RESEARCH AND DATA TO INFORM LEGISLATIVE DECISIONS.

Q: ARE THERE SPECIFIC TYPES OF CRIMES THAT ADVOCACY GROUPS FOCUS ON FOR REFORM?

A: YES, MANY GROUPS FOCUS ON SPECIFIC AREAS SUCH AS DRUG OFFENSES, NON-VIOLENT CRIMES, AND OFFENSES WHERE RACIAL OR SOCIOECONOMIC DISPARITIES ARE PARTICULARLY PRONOUNCED. HOWEVER, BROADER REFORM EFFORTS OFTEN AIM TO ADDRESS SYSTEMIC ISSUES THAT AFFECT ALL TYPES OF CASES.

Q: WHAT ROLE DOES RESEARCH PLAY IN THE WORK OF CRIMINAL JUSTICE REFORM ADVOCACY GROUPS?

A: RESEARCH IS FUNDAMENTAL. ADVOCACY GROUPS USE DATA AND EVIDENCE TO HIGHLIGHT SYSTEMIC PROBLEMS LIKE OVERCROWDING, RACIAL BIAS, AND THE INEFFECTIVENESS OF CERTAIN POLICIES. THIS RESEARCH FORMS THE BASIS FOR THEIR POLICY RECOMMENDATIONS AND PUBLIC EDUCATION EFFORTS.

Q: HOW CAN AN INDIVIDUAL SUPPORT CRIMINAL JUSTICE REFORM ADVOCACY GROUPS?

A: INDIVIDUALS CAN SUPPORT THESE GROUPS BY DONATING TO THEM, VOLUNTEERING THEIR TIME, PARTICIPATING IN AWARENESS CAMPAIGNS, CONTACTING THEIR ELECTED OFFICIALS, AND ADVOCATING FOR REFORMS WITHIN THEIR OWN COMMUNITIES. STAYING INFORMED ABOUT THESE ISSUES IS ALSO A CRITICAL FORM OF SUPPORT.

Q: WHAT ARE SOME COMMON MISCONCEPTIONS ABOUT CRIMINAL JUSTICE REFORM?

A: A COMMON MISCONCEPTION IS THAT REFORM MEANS BEING "SOFT ON CRIME." IN REALITY, REFORM OFTEN AIMS TO CREATE MORE EFFECTIVE PUBLIC SAFETY STRATEGIES BY FOCUSING ON REHABILITATION, ADDRESSING ROOT CAUSES OF CRIME, AND ENSURING THAT PUNISHMENT IS PROPORTIONATE AND JUST. ANOTHER MISCONCEPTION IS THAT REFORM BENEFITS ONLY THOSE ACCUSED OR CONVICTED OF CRIMES, WHEN IN FACT, MANY REFORM EFFORTS ALSO FOCUS ON SUPPORTING VICTIMS AND BUILDING SAFER COMMUNITIES FOR EVERYONE.

Q: HOW DO RACIAL DISPARITIES MANIFEST IN THE US CRIMINAL JUSTICE SYSTEM, AND HOW DO ADVOCACY GROUPS ADDRESS THIS?

A: RACIAL DISPARITIES ARE EVIDENT IN DISPROPORTIONATELY HIGH ARREST, CONVICTION, AND INCARCERATION RATES FOR BLACK AND HISPANIC INDIVIDUALS COMPARED TO WHITE INDIVIDUALS, EVEN FOR SIMILAR OFFENSES. ADVOCACY GROUPS

ADDRESS THIS THROUGH ADVOCATING FOR AN END TO RACIAL PROFILING, DEMANDING EQUITABLE POLICING PRACTICES, PUSHING FOR SENTENCING REFORMS THAT ELIMINATE BIAS, AND HIGHLIGHTING THE HISTORICAL ROOTS OF THESE DISPARITIES.
